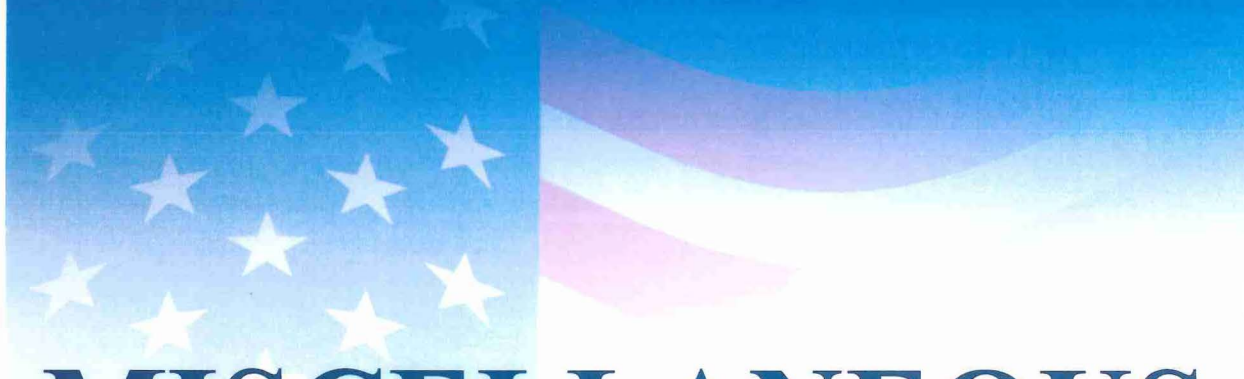




**Shall the limiting rate under the Property Tax Extension Limitation Law for the New Lenox Community Park District, Will County, Illinois, be increased by an additional amount equal to .0620% above the limiting rate for levy year 2012 for park purposes and be equal to .2314% of the equalized assessed value of the taxable property therein for levy year 2014?**

(1) The approximate amount of taxes extendable at the most recently extended limiting rate is \$2,036,069, and the approximate amount of taxes extendable if the proposition is approved is \$2,782,069.

(2) For the 2014 levy year the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$16.95.

(3) If the proposition is approved, the aggregate extension for 2014 will be determined by the limiting rate set forth in the proposition, rather than the otherwise applicable limiting rate calculated under the provisions of the Property Tax Extension Limitation Law (commonly known as the Property Tax Cap Law).







**Shall the limiting rate under the Property Tax Extension Limitation Law for the New Lenox Fire Protection District, Will County, Illinois, be increased by an additional amount equal to 0.129% above the limiting rate for levy year 2012 and be equal to 0.489% of the equalized assessed value of the taxable property therein for levy years 2014, 2015, 2016 and 2017?**


(1) The approximate amount of taxes extendable at the most recent extended limiting rate is \$4,292,751, and the approximate amount of taxes extendable if the proposition is approved is \$5,830,987.

(2) For the 2014 levy year, the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value of \$100,000 is estimated to be \$43.00.

(3) Based upon an average annual percentage increase in the market value of such property at (-4.337)%, the approximate amount of the additional tax extendable against such property for the 2015 levy year is estimated to be \$35.93, for the 2016 levy year is estimated to be \$29.17, and for the 2017 levy year is estimated to be \$22.70.

(4) If the proposition is approved, the aggregate extension for 2014, 2015, 2016 and 2017 will be determined by the limiting rate set forth in the proposition, rather than the otherwise applicable limiting rate calculated under the provisions of the Property Tax Extension Limitation Law (commonly known as the Property Tax Cap Law).
