## Official Write-In Results

### February 24, 2015 Consolidated Primary Election

**Per Statute 65 ILCS 5/3.1-25-40(b):** For nonpartisan municipal primaries if the name of only one candidate for a particular office appeared on the primary ballot, the name of the person having the largest number of write-in votes shall not be placed upon the ballot at the general municipal election unless the number of votes received in the primary election by the person was at least 10% of the number of votes received by the candidate for the same office whose name appeared on the primary ballot.


