The landscape plan should incorporate native species that are compatible with the neighboring Midewin National Tallgrass Prairie. The landscape plan shall be submitted to the Will County Land Use Department within ninety (90) days of County Board Approval and shall be implemented within one (1) year of County Board Approval.
- 3. The owner of record shall obtain an "after the fact" site development permit for work previously performed.

Member Gerl presented background about this resolution. Basically, our Workforce Services is primarily funded by the federal government using the state as a pass through. What's happened is the state is not funding the Workforce Services fund on a timely basis and Workforce Services is pushing off paying a lot of its vendors, which are typically consultants utilized in the job retraining of our citizens here in Will County. We also have a payroll at Workforce Services as well. What's happening is since the state is not reimbursing us with the federal dollars that they receive as a pass through, we are forced into the situation where we have to loan them \$100,000 just to make sure that our payroll down there is paid timely, and then get the reimbursement from the state. I guess the reason why I point it out is really it's just one more area where the state being so dysfunctional is causing hardship not only to the county, but also to the citizens of our county because they rely on this type of job retraining. The Finance Committee did send this over to the Legislative Committee, who is going to hear it next month. and hopefully we can send a letter to the appropriate legislative people down in the state in order to help us in this situation. Workforce Services was looking for \$300,000 because there's a couple hundred thousand dollars of bills that do not get paid on a timely basis. We wanted to make sure that our people got paid timely and we're going to get a further analysis from Paul in the Executive's Office just to see what this \$200,000 is made up of. Hopefully we can things straightened away so we can get a timely reimbursement.

Member Svara said let's see if I understand this. The federal government is giving the State of Illinois money for this program. And the State of Illinois is not passing that money down to where the expenditures are. Are they using it for something else? Is that legal?

Member Gerl responded I couldn't tell you what the state is using it for, but your first comment is correct. The federal government, using the state as a pass through is giving the money to the state, but it's not making its way down to us in a timely basis. That is true. What they're using it for, I have no idea.

Member Svara asked, is that legal? Rhetorical question.

Member Gerl replied, again, ...

County Executive Walsh asked who are you asking?

Member Svara said, rhetorical question, I'm asking no one.

County Executive Walsh said I don't think you're getting an answer from no one. I guess you'll have to address that to the Attorney General.

Member Moustis commented, I don't know if it's legal or not, but what would your remedy be. I think it would be highly unusual to force the state to do it. Certainly, I think, to also ask the Executive's Office to participate. We should all contact our representatives who represent Will County and express to them this is a concern. This is a retraining program for workforce in Will County, it's extremely important. And, it's not something the state should not be sending the funding down to us when they receive it from the federal government. I do think we should contact our state representatives also.

Member Konicki said I think the question is a good question and ought to be taken out of the rhetorical context and be made an actual concrete question. Obviously the attorney we address it to I think would be Mr. Glasgow. He may not be ready to give an opinion this morning, but I think it's an issue in which he ought to -I would ask that he take a look into it and do give us his best advice and insight on the legality of the money not being sent where it was intended to go.

State's Attorney Glasgow responded, do you mind if I ask them why they hold my raise back, my cost of living back six months every year at the same time? If they are using it for something else, that could create a legal issue. Obviously we know the dire straits the state of Illinois is in budget-wise. So, they're probably moving money around before they send it out. Maybe somebody should look into it. I will give the Attorney General's office a call.

Member Konicki responded, I appreciate that.

Member Gerl stated maybe a few of these questions – this resolution is going to be referred over to the Legislative Committee, so possibly the Legislative Committee and the State's Attorney's office can work together on it.

Member Singer said I just want to take a very quick minute to make a couple quick comments about an issue that could very well impact this committee and certainly the whole Board. As you may have read in the paper, there's been a proposal that's passed the legislature that would ultimately fund a significant amount of money into our County Highway budget. It's a sales tax increase passed by the legislature that would increase sales taxes in the collar counties by a half penny and in Cook County by a quarter of a penny. Just so we all understand, the collar counties pay a half a penny, Cook County pays a guarter of a penny. Half of our half penny, so our quarter penny, goes to pay for the RTA and CTA. So the collar counties are paying for Cook County's transportation and Cook County pays for Cook County's transportation. But the missing part of that element is that Cook County isn't paying for the collar county transportation. It's passed the legislature and assuming the Governor signs it or some sort of an abbreviated version of it, I'm sure we can find a way to spend those monies on road improvements in Will County. That's not going to be the issue. But doing this, and every time we would spend those monies, we're always going to remember that for every dollar we're sending to Springfield, we're getting back 50 cents. Here again is yet another example of the cost of Cook County and the cost of this administration onto the collar counties and how we are paying for it every day. We can thank legislature for that. Now the Governor is playing a few more political games in his recent proposal offering free bus rides to senior citizens, which can very well put an additional tax burden on Will County taxpayers. Very quickly, I think if we're not, we should all consider growing a little tired of seeing politicians tossing crumbs at senior citizens and expecting them to be ever so thankful for, for example, a free bus ride after they have paid taxes, held jobs, raised families and won wars for decades. These are people experienced, these are people of wisdom, and have a real perspective of life. I venture to guess they're not upset because they don't want a free bus. I imagine they're upset because they're curious about what this free bus is ultimately really going to cost them. And, with this Governor and with this legislature, that's a very real question. We may be at a point with this Committee where you start seeing us having the ability to spend a lot more money on roads. That may very well happen and that will be exciting, because we do need road improvements in Will County. But every time it happens, for every dollar we spend to Springfield, we're getting back 50 cents. I just wanted to take a moment to highlight that.

Member Adamic commented with all due respect, it was my understanding that it's only going to be a quarter percent of one percent is what we're going to be charged and that the formula has been changed. It was 60/40 split for CTA and collar counties, where now it's going to be 52/48 split. So, with that, there may be some confusion with regards to what this bill or

what it comes out to be here. I just want to try to help make that clear, that we're only going to be charged a quarter of a percent. That's my understanding at this point.

Member Moustis said I also read the bill. The bill gives 15% of our quarter percent for the first year to Cook County. Did you see that in there? This is not something that I'm thinking is a great deal. It's a tax increase; it's a huge tax increase. It's a tax increase for Cook County. If anybody in this room or in this county want to be grateful for a few crumbs that get thrown our way, think again. They're already cutting into our quarter percent; just give them time and they'll get the whole thing.

Member McMillan stated, and Wally, I think you need to understand that the mass transit ridership, Will County has 85% of its population that never avails itself of mass transit. So, it's the remaining 15% that will be utilizing it, and this is where that tax increase is going to as well.

Member Adamic said we're going to probably be getting about \$19 to \$20 million that we're going to be able to use for our road improvements and perhaps public safety too. No one wants to pay any more taxes than anybody else in this room, myself included. But, we were looking at a gas tax before, but maybe this is another way. It's another way that we need to help fund roads. This will be one of the good things that comes out of this is that we'll be able to fund our road improvements that we so desperately need. No one wants to pay any more taxes than anyone else, but it's got to come from somewhere.

Member Singer commented, very quickly, I don't think anybody in this room likes tax increases, even our friends on the other side of the aisle. But, let's in the spirit of John McCain, let's have a little straight talk about this. This Board asked the legislature to consider a resolution where we could put on the ballot an initiative asking for a gas tax, so we would let the Will County residents choose do you want to do this or do you not want to do it. Every voter could have their voice heard on whether they want to have a gas tax increase to pay for Will County roads or not. The Governor vetoed it and he vetoed it based upon his opposition to tax increases. And in an every so high mighty way of doing it said no, I won't support tax increases. Could anything then be more hypocritical than to come back and say what we're going to do, Will County, is impose virtually the same tax on you now, but you're just going to get half of what you had originally asked for. So you're going to pay the same tax anyway, except now we're just giving half of what you would have paid and then received all of; instead we're going to send half of that to Cook County. If we're going to talk about it, let's be straight about it. What we're seeing here is the absolute result of what we all expected. When you have a Governor and a Senate President and a Speaker of the House, and a strong majority of the members of both of those chambers who all live within a couple miles of each other, the collar counties and Will County are going to hold the burden of that. That is specifically what we are seeing here today; that is the proposal that was passed through the legislature and is the kind of stuff we're going until things change in Springfield. Frankly, everybody in this room, Democrat, Republican, it doesn't matter, should be upset about this. Sure, ultimately we'll get a lot of money for roads, but what we're paying to get that money for roads is significantly more. This is a horrible deal and an example of the kind of culture in Springfield and what is happening to us, residents and elected officials in a collar county.

## CRIMINAL JUSTICE, LAW & JUDICIAL COMMITTEE Anne Dralle, Chairman

Member Dralle said we have a presentation that I'm sort of excited to introduce the people who are involved in this. I look at it as sort of a public safety announcement. Member Dralle introduced Julie McCabe, our Will County Drug Court Coordinator, and Mr. Dave Talarico, President of SCRAM. SCRAM stands for Secure Continuous Remote Alcohol Monitor; in other words it's an alcohol breathalyzer for the leg and this ankle bracelet is being used in Will County. Just for a little background, there's approximately 2600 DUI arrests a year, and there's an additional thousand DUIs that are incarcerated at the Adult Detention facility. Using an alcohol monitoring program for individuals who meet specific criteria is a cost effective alternative to jail and allows the DUI offender to work and continue to be a productive member of our Will County society. The Honorable Judge Carla Policandriotes oversees this pilot program. The bracelet monitors the offender 24 hours a day, 7 days a week, 365 days a year. I did have the opportunity to wear one of these. I think if we're going to use them and promote them, then let's wear them. It was an interesting experience; I don't know if I'd do it again.

Mr. David Talarico and Julie McCabe-Sterr gave a presentation of SCRAM, Secure Continuous Remote Alcohol Monitor.

Questions from County Board members:

Member Maher asked what is the normal consequence for somebody that might be reoffending and with that time frame almost over a year, how soon would somebody be pulled back if they were busted.

Ms. McCabe-Sterr replied if they give me a report the next day, the warrant is issued and we go pick them up. They're incarcerated within a day and then it's a case-by-case basis with drug court whether we let them go back to treatment or whether we summon them to DOC.

Member Svara said I presume this measures the alcohol level in the blood.

Mr. Talarico responded what it does it's similar to a breathalyzer for the leg, but it's a transdermal alcohol content; so it's actually – our bodies are always releasing gases, whether it's the hottest day of the year or the coldest day. We've all experienced those, someone and they wreak like alcohol. That's become it's coming through the pores.

Member Svara interjected, then to get to my question, there was a list up there and I could see DUI, that's logical. But the others that were on the list, how do you know that this is the alcohol you say 80% on some. Have there been any court cases where you've had to use this information that stood up.

Mr. Talarico stated I've testified probably a dozen times in Kane County and everytime but one it stood up. The one time it didn't stand up was because the guy spoke Polish and they didn't have a Polish translator at the time. Going back to your question, it's been tested throughout the country. That standard of testing in Will County and Illinois is what's called a fry hearing, which breathalyzers you had to go through years ago. It passed a fry hearing in July of 2007 in southern Illinois and it was found favorable in SCRAMs.

Member Svara asked can a defendant refuse?

Mr. Talarico responded they can certainly refuse to go along with it but they also face the consequences. Most of the people that I have either, if they go on the bracelet, they keep their driver's license. Or if they go on the bracelet, they avoid jail time, or they reduce the jail time. The consequences are all different, depending on the county. I have people on in three different counties.

Ms. McCabe-Sterr said in drug court they can't refuse; it's part of their contract.

Mr. Gerl asked Mr. Talarico, have we, it sounds like we can certainly save a substantial amount of money down at the ADF; we can reduce the overcrowding. You've done various studies here to prove that it's effective. What's our plan for implementing this; I can't really see a downside. It doesn't cost the county anything because it sounds like the user is paying for it. We get \$15 that's going to be coming to the county, which is going to be, a couple of dollars are going to go into a fund to help those pay that can't afford it. What is – it sounds like we're doing a pilot program. What's the timeline – what is the timeline for implementing this. It sounds like a very efficient way to monitor these people.

Mr. Talarico responded John, I could start it today if I got referrals. But basically, it's a combination of the State's Attorney's office as well as their judges. It's new technology; people are always weary about new technology. Like I said, I've got over 100 people on it right now in different counties – we do have five people on it in Will County. Judge Policandriotes is definitely using it; it's just trying to get the word out and doing things like this.

Member Dralle said I think, John, maybe I can answer that for you. What we're going to do at least from a Judicial Committee perspective is I'll be going up to Kane County with Mr. Friefeld in the next couple weeks talking to some of the individuals that have implemented this program in Kane County, bringing that information back and then asking some of the people in Kane County to come to some of our committee meetings and to go through this process as we educate ourselves. Hopefully the judicial system will also be interested in implementing this.

Member Gerl said I guess my only question is if there's not a timeline, it just seems like the process will never get done. So, it seems like we almost need a step by step, we're going to go visit Kane County, we're going to do this, we're going to do that, and we're going to implement it. Is there an initial upfront investment by the County to buy the bracelets, or how does that work? Mr. Talarico replied no, the County doesn't buy the bracelet, I buy the bracelets. I have the bracelets now; there's no investment at all by the County. The only thing is when the client gets ordered to wear it, they come in and they start wearing it.

Member Maher asked, with the alcohol monitoring, are you also involved in any of the home monitoring. If you're going to put on one bracelet, could this have a dual capabilities.

Mr. Talarico answered in the future it definitely will. That's the goal by the end of 2008 to incorporate electronic monitoring within the bracelet. As it stands right now, it does not do that. I actually have a guy in Aurora that wore a home monitoring on one and then a SCRAM on the other. We hope to resolve that problem.

Member Moustis said of course the Judicial Committee of the County Board and the County Board has been advocating this for some time, that we look at some alternatives to putting people in our jail, especially since it's overcrowded. But can you perhaps give us an insight on a more national basis on what the trends are using bracelets, monitoring people outside of the detention center?

Mr. Talarico responded there are over 7,000 people monitored on a daily basis throughout the country using 44 states now. South Dakota, their entire work release program in the state is SCRAM type program. It is definitely building steam. It's very, very small compared to a lot of other house arrests, and things like that because it's such new technology. It's about four or five years old. Right now, it's about 7,000 people.

Member Moustis continued, can you give us some figures, maybe not right now, perhaps other larger metropolitan areas that may be going forward with these technologies in a more aggressive manner. I'd just be interested in maybe talking to some of those counties to see some of their results.

Mr. Talarico said Indianapolis is one, I think it's Marion County. They use it extensively.

Member Konicki said these certainly seem to work for giving us a heads up when someone is not complying with the terms of their probation or their contract with the Drug Court and need to be locked back up. Do you have any data on whether these bracelets reduce the recidivism rate. I know they wear them like 244 days; that's a pretty good period of time to get some good behavior in place. Does that behavior tend to stay in place more so than if the bracelets had not been used and possibly cheating could have gone on?

Mr. Talarico said I know they're doing a recidivism study now. It's not completed. I know in my experience over the past year I've had over 91% success rate, which is higher than the national average; the number of days is higher than the national average.

Member Konicki said what does the 91% refer to?

Mr. Talarico replied that there's no violations – they didn't drink.

Member Konicki interjected, so they get through their 244 days because they know perfectly well if they're in the bracelet and they cheat, they're going right straight to jail. So I would expect that to be a high compliance rate. But, after the 244 days.

Mr. Talarico responded, I can tell you from my personal experience, that we haven't been around long enough with enough people to actually have that data. I do know that AMS in Colorado, which is the manufacturer, they are doing the study. I'm not sure where they are on that, but I can certainly get that information to you as soon as I have it.

Member Svara added, so you have an intervention here. Have there been any studies that compare the intervention with a non-intervention?

Mr. Talarico replied, for the last 18 years I've been involved with the DUI population, and if you can ever get to 80% success rate, you are doing fantastic in a treatment program. I don't know, it's kind of apples and oranges; all I know is that I've seen, in your packets that you have, you have a letter from a sister of one of the clients that I've had and basically she's said that it saved her brother's life. That doesn't happen very often when you hear somebody that's willing to put that in writing.

## LEGISLATIVE COMMITTEE Lee Goodson, Chairman

Member Goodson said I'm going to apologize in advance; Legislative update is beginning to sound like Groundhog Day. The RTA is the bill I'd like to update you on today. Just to sort of recap the bill, this is of course to provide a funding source for the RTA. In the bill there is some language that the RTA bill has increased their board members from 13 members to 16 members, and one of those appointments will be for Will County, the Executive will make the appointment with the advice and consent of the County Board. The Metra Board has also been increased from 7 members to 11 members, with one appointment to be made by the Will County Executive with the advice and consent of the Will County Board. Also in this bill, the City of Chicago, the City Council will increase their real estate transfer tax from \$7.50 to \$10.000, and that additional money will go to the CTA. The RTA tax was increased by a quarter percent to be used for their operation and an additional quarter percent for each of the collar counties to be used by each county for operations, capital costs, public safety, transportation services, and that includes roads, bridges and public safety. As we all know, the Governor amendatory vetoed the

bill and added free rides for all of our senior citizens on all public transit. Yesterday, the House Mass Transit Committee voted to approve the Governor's amendatory veto. Today the vote will be going to the full legislature and will be portrayed as a vote to sort of advert the doomsday crisis instead of solely regarding the senior issue. For procedural reasons, the aid does not pass, the whole plan might be in jeopardy. Two issues that I want to make you aware of, and these are just something that was discussed that is not necessarily gong to happen, but there is some consideration for a trailer bill. What that is, is setting income limits on the eligibility for the mass transit, the free rides for the seniors. As you are aware, and as Cory Singer mentioned today, one quarter of one percent of the collar counties would receive one quarter percent of that tax money and that would be implemented by the RTA. Some Chicago legislators want to propose an amendment to that and suggest that the county boards should be the ones to approve the tax and not the RTA. If this does pass today, and session is to begin at 11:00, so we should be hearing relatively soon, there may be an amendment in the trailer bill that this resolution would come to the county board and not be automatically implemented by the RTA.

Member Goodson stated, I think the question is what if we don't impose the quarter percent tax and what would happen is we just would have the one quarter percent tax to go to the RTA.
