Member Gould stated good morning County Executive Walsh I have no Resolutions this morning and that concludes my report.

LEGISLATIVE & POLICY COMMITTEE Lee Goodson, Chairman

Member Goodson began good morning everyone and Happy New Year. 2010 brings us to our next Legislative Session and in your packets you have copies of our draft Federal and State Legislative Initiatives. I just wanted to review them very briefly and entertain any questions anyone might have. First our Federal Agenda, we have comprehensive agenda that has a brief explanation of the initiatives as well as a detailed explanation behind the summary report. This has a little bit of something for everybody.

First for Public Health: We will be requesting \$500,000.00 from the Department of Public Health & Human Services. If we're successful in the funding will be used by our County Health Dept for community-based services for intervention and treatment of mental illness. This includes children, adults, and Veteran's.

We had received an earmark once before this before, but we were not successful in securing the funding so we hope that this will help, if we are unable to secure it, this will provide additional providers to help with mental illness issues.

Secondly, we are requesting \$690,000.00 to continue our Phase II of the Integrated Criminal Justice System. We were successful in securing \$300,000.00 in 2008 and \$100,000.00 in 2009. Currently of 65 of our 270 patrol cars have cameras in them as well. This is the second dollar amount that we are requesting for \$300,000.00 from the Department of Justice. This additional \$300,000.00 will provide an additional 65 cars with cameras.

Under Transportation we are requesting \$1,180,000.00 from the Department of Transportation's Federal Highway Administration for Phase I engineering of County Highway 83 for reconstruction and grade separation. Our current average daily traffic is over 16,000 and growing since its one of only two accesses along I-80 in this area.

We will also be requesting \$960,000.00 to begin Phase II design for the intersection of Bell Road and 143rd Street to improve capacity and safety. This intersection ranks as one of the worst intersections in the County for accidents.

Requesting \$450,000 from the Federal Aviation Administration for the creation of a multijurisdictional land-use plan. This plan will be for the footprint of the Peotone Airport.

In anticipation of the Re-Authorization of the Federal Surface Transportation Bill we are requesting \$79 million for Weber Road and I-55 interchange; and also \$10 million sof the Laraway Road Corridor Improvement (Phase I Engineering). These two projects that will be requesting funding from the Federal Surface Transportation Bill as we usually do, we have one project in each Congressional District that is important to Will County that we feel our Federal Representative can get behind.

Under Land Use & Infrastructure, first of all Land Use we have a number of water projects. We have the DuPage River Flood Study. This is a \$1 million request from US Army Corp of Engineers. The total cost of the Flood Study will be approximately \$5 million. This will involve a multi-phase approach that will take approximately 3 years to complete. The total cost will be about \$5 million. This will Include HYDROlogic as well as HYDRRAULic modeling. Our most recent Flood Study was done in 1982 and is terribly outdated. And since 1982 residents from Wheatland, Plainfield, Shorewood, Channahon, Joliet, and Minooka are experiencing more frequent flood events. This would help to study the river and the precipitation and help to determine what exactly is going on with our water. To sort of piggyback on that, we will also be seeking authorization from WRDA (Water Resource Development Act) to authorize other projects for flood studies for Prairie Creek; a maintenance project for Fiddyment Creek and additional funding for the DuPage River Flood Study.

In complete contrast to that, we will also be requesting funding for our Water Supply and Planning Project. We have been hearing for a couple of years now that there is a potential drinking water shortage. So this would provide funding to look at the water supply status and compile a planning report. There evidentially has been decreasing trend of hydrologic conductivity in Cook County and the anticipation is that not too many years from now that there could be a shortage of drinking water here in Will County. So this would look at that issue.

Under the Land Use and Infrastructure they will be requesting \$350,000.00 for Economic Development and Transportation Study. This is from the Department of Housing and Urban Development for Economic Development Plan. We will be exploring the impact and the needs for the increased intermodel and freight traffic and the CED is also, in conjunction and partnership with the County is doing an Inland Port Study. So we will see the impact of the additional freight the intermodels will have on our County and how to address it and how to plan for it.

Finally, under Workforce Development, The Workforce Investment Act Re-Authorization was supposed to be completed in 2003 and it is still not done today. We are requesting that when they do this Re-Authorization Act that we maintain our current status that allows local control and we support local control.

We will be meeting with our Federal Legislators in March, as we always do in conjunction

with our NACO Conference. So we will be sitting down and talking about our initiatives and hopefully getting some support. We have had a lot of success in the past and we anticipate additional support in 2010.

Member Goodson asked, does anyone have any questions about the Federal Agenda?

County Executive Walsh asked, does anyone have any questions? I think you explained it very thoroughly.

Member Goodson continued, the second Resolution that I have is for our State Agenda and in 2010 we will continue some of our prior initiatives. One of them being to continue to support the development of the Peotone Airport and as we discussed so many times, we have support from our regional business, labor, unions, our local Legislators and we continue to seek approval of the airport. This will be a public/private partnership and the Governor has expressed support and has committed some funds to this and will continue to work with our State Legislators to move that forward.

Something new in our agenda this year is the Illiana Expressway. While we have been discussing this for several years, originally this was a new east-west roadway between I-57 and I-65, which is partially in Indiana. Now there are looking at a new corridor which includes further west between I-57 and I-55. This is a 50 mile project and we are seeking funds to develop this roadway as it will be very important as we move forward with our development of intermodals and the airport as well as a great economic opportunity.

We will continue our fight against Senate Bill 1607, the Quarry Construction Debris Bill. As we have discussed many times, because of our water table in Will County it is especially dangerous with the potential contaminates that will be leaked into our water system and we have discussed our objections with our State Legislators. This has passed the State Senate and is currently in Rules in the House. So the potential of this moving forward this session is very possible if not probable.

Also our other Legislative priorities: We have had two successful with cell towers and yet we see the need to continue to pursue further setbacks from our residential

property lines and in addition to setbacks we are also going to request that included in that legislation there be some requirement for the latest technology which, my understanding is called "crumple tower technology". If there was an event of a tornado the tower would actually, if it were to fall would actually break in half and would not impact surrounding structures.

Probation Services we have discussed a lot at Legislative Committee and the State was to fund this at 100 percent and they have yet to do that and in fact they continue to erode the amount of funding that they provide to the County and we are forced to absorb these costs. With the passage of the Cindy Bishop Bill, which in a lot of ways is a very positive thing, that really puts an undue burden on the County. This is also an initiative that Metro Counties has taken up.

We also have a paragraph in here regarding pension reform. This is something that we discussed in Republican caucus that we may revisit as far as including this in our actual packet. But this is something that has created a lot of challenges for the State as well as the local municipalities in terms of budgeting and the idea of moving forward with the two tier system has been discussed at great lengths. This is also an initiative that is important to Metro Counties but we are going to have further discussions about this one in Legislative Committee.

Also, any reduction in our existing authority, we have always been opposed to that.

Finally, in the packet we have included several road projects, one or two in each one of the State Representative Districts. Something that they can get behind and support in their districts that would be beneficial to the County of Will. And hopefully we can secure some funding in the capital bill for these projects that are waiting and ready to move forward.

(b) The governing and administrative powers of the Authority shall be vested in a body consisting of 10 members including, as an ex officio member, the Director of Commerce and Economic Opportunity, or his or her designee. The other 9 members of the Authority shall be designated "public members", 3 of whom shall be appointed by the Governor, 3 of whom shall be appointed by the county board chairman of Will County, and 3 of whom shall be appointed by the county board chairman of Kankakee County. All public members shall reside within the territorial jurisdiction of this Act. Six members shall constitute a quorum. The public members shall be persons of recognized ability and experience in one or more of the following areas: economic development, finance, banking, industrial development, small business management, real estate development, community development, venture finance, organized labor or civic, community or neighborhood organization. The Chairman of the Authority shall be elected by the Board annually from the 6 members appointed by the county board chairmen.

(c) The terms of all members of the Authority shall begin 30 days after the effective date of this Act. Of the 9 public members appointed pursuant to this Act, 3 shall serve until the third Monday in January 1992, 3 shall serve until the third Monday in January 1993, and 3 shall serve until the third Monday in January 1994. All successors shall be appointed by the original appointing authority and hold office for a term of 3 years commencing the third Monday in January of the year in which their term commences, except in case of an appointment to fill a vacancy. Vacancies occurring among the public members shall be filled for the remainder of the term.
