Member Konicki stated that what I noticed on this case is that we foreclosed in November of 2008. Almost two years ago. We had foreclosed in a \$2 million Letter of Credit. But then we never went ahead and did the improvements although we had the money to be doing the improvements, we didn't do them. We foreclosed because the developer wasn't making the improvements then we got the money and we didn't make the improvements. And it concerns me because I think that to the extent we simply sit on the money rather than using it for its intended purpose we hurt local taxing districts. Because certainly finishing the improvements of the subdivision increases the value of the land which increases the revenue to the local taxing districts. And what I'm looking for, what I would like to receive at the Land Use Committee level is a report on the proportions we've done let's say in the last five years, the amount of money, the developments and what we've done with that money. Whether we've actually done what we were supposed to do. In this situation I support returning the money to the bank

who is now the owner of the land so that they can actually get the improvements done. But on the other hand I'm very disappointed in this County that we didn't get those improvements done immediately when we got the money. I'd like to ask Member Weigel, Land Use Committee whether you will put this issue on our Agenda so there is some accountability on these foreclosure funds. I'd like a report on it so we know what the pattern has been, because it surprised me. I had no idea we that we had sat on those Palomino funds. \$2 million and didn't make the improvements and that's not acceptable.

County Executive Walsh asked Member Weigel would you like to respond.

Member Weigel asked Mr. Curt Paddock, Land Use Department, if he would respond to that. Do we intend to have a running commentary on foreclosure letters?

County Executive Walsh asked Mr. Paddock to please come forward.

Member Moustis stated the Executive Committee on the County Board makes a determination what Committee listens to what issues. If this is an issue it should be sent to the County Board office so it can be considered for placement on the Agenda; which the Executive Committee makes the determination what Committee is best suited to do this endeavor. So I wouldn't assume it's going to go to Land Use, number one. Even though Land Use does have an obligation and they do close on the letters of credit. It doesn't mean after that they make a determination how that work is going to be done. And, this might be a broader policy issue for the County Board. So Member Weigel can, or any member can submit the issue to the County Board office and it will be placed on the Agenda at the Executive Committee.

County Executive Walsh said thank you Member Moustis. Member Konicki...

Member Konicki stated I'm sorry that's absolutely not acceptable. As an elected official I'm asking for accountability on funds that have been foreclosed...the funds that we have in our account that have been foreclosed. I want the information. I'm asking for a report from staff. I'm asking for the information and I don't care to have to submit a written request to you on the chance that you may decide not to do anything with it whatsoever. I think that this is information that all County Board members should be demanding right now. And, that the public should have.

Member Moustis responded first it's an issue more in my opinion... it's more of an issue for the Finance Committee. Member Konicki you can request any information from the Executive's office or any other office that you choose. But we here at the County Board have a process and I know you don't always like the process, but once again if it's going to be looked at, then it goes through the Executive Committee for placement on the Agenda. If you as an individual, County Board Member and citizen want to make a request, go ahead.

Member Konicki stated I made the request here this morning, I'd like a report. I need our staff to go into their files pull the information out of their files and make a public record of accountability for these funds. Personally I don't care what Committee you run it through. I just want the information; I want a report on it and I'm asking if you... I don't need a written request. We're sitting here in a meeting this morning, a public meeting on camera and I'm making a request for the information for the report.

Member Moustis request of whom?

County Executive Walsh stated Member Konicki, Member Moustis has given you an answer and a solution that the proper procedure, according to the County Board, has been, you submit a request to the County Board and it will be handled.

Member Konicki responded it hasn't always been handled in the past. I've made a request publicly and I'll follow it up on paper but I want it as public issue. And we need the information. We have a right to it.

County Executive Walsh replied the County Board works on an arrangement of Committee work and that is what Member Moustis is saying and has laid out a plan for you to get your information and that's it.

Member Konicki responded that I have made requests like this before and Member Moustis has killed them.

Member Moustis stated that's absolutely not true. And as a matter of fact Member Konicki you know that's not true because you were instrumental in having the rules changed. You can make any request that you want. You regularly do. You inundate this County with FOIAs all the time. Continually.

Member Konicki states I just want the report....just please get the information. Thank you.

Member Moustis stated that just because you demand a report that doesn't mean we have to produce it. Sorry.

County Executive Walsh stated let's continue. Member Anderson...

Member Anderson stated I want to make a quick comment. This subdivision is sort of an eyesore because of its condition. I drive by it pretty regularly and I was not aware that we were sitting on this letter of credit. I would not have been pleased had I known that. To the extent that First Midwest Bank is going to move forward and actually implement these improvements then I support the Resolution. But, I do think Member Konicki does raise some good points that we should keep track of this in the future.

Member Kusta replied that next he would like Auditor Duffy Blackburn to come down for his Quarterly Report.

Auditor Duffy Blackburn stated good morning County Executive Walsh, Chairman Moustis, Finance Committee Chairman Kusta; I'm presenting today the Quarterly Financial Report and it ended May 31, 2010. Looking past the cover letter you'll see again expenditure, budgetary comparison and this will show up in the general corporate account with expenditure budgetary controls. It looks to be we're at 45%, halfway through the year, which is appropriate. Looking to the next page you can see the highlighted nine largest departments of the corporate fund which are the County Board, Worker's Compensation, the Support Services, Sheriff Administration, Sheriff Custody of Prisoners, State's Attorney, Circuit Clerk, Juvenile Detention Center and then lastly the Sunny Hill Nursing Home. County Board you can see is only at 23%, all the rest make their way up to about 50% so the budget controls in each of these departments looks to be appropriate as well. To talk about the revenues, the only revenue that seems to be lagging behind is the interest, which we looked at last year and then budgeted it at about \$5 million. We only had about 7% in so far. That does include the tax sale, which we haven't gone through that process yet. The property tax is also, you'll see, only at 4% at the end of June. Now the distribution has come in. About 33% of the distribution has been made on June 3rd for the County, so we're well within our levy. The other points of interest would be to look

at some of the salary and fringe benefits and their budgetary comparisons. That is the last page in your report. And as you can see most of them on average the total is at 48%, so the salaries being appropriate as well. Now this is available on line at www.willcountyillinois.com on the Auditor's page. Also in the coming months I'll let you know that the Auditor's office will now be presenting putting on file a claims paid list for bills, paid list. And we will be presenting that to the County Board as a whole. Also with that the claims paid list, the expenditure report basically a check register is available on line now in the Auditor's website as well. Next month I'll put together a few more informational graphical sheets that show just makeup of the county as a whole, separated by function, by the public safety function, by the health and welfare, general administrative, the highways and roads, and then the judicial. So we'll take a look at how large these are; the number of employees, their salaries, the number of elected officials within these different functions. So you can just have a big picture view going into the budget and the discussions you will have pertaining to the budget. Are there any questions?

County Executive Walsh asked if anyone had any questions. Member Weigel...

Member Weigel stated this report says First Quarter ending May 31, but isn't this the Second Quarter?

Auditor Duffy Blackburn responded you are right. It should be Fiscal Quarter May 31, 2010.

County Executive Walsh asked if there were any other questions. Thank you Auditor Duffy Blackburn.

Auditor Duffy Blackburn stated thank you, have a good day.

# LEGISLATIVE & POLICY COMMITTEE Lee Goodson, Chairperson

Member Goodson stated good morning everybody. You should find on your desk a written report that I've provided for you. These of course are a handful of the bills than went through the legislative process this past session. Many of them, most of them have actually passed both houses and are on their way to the Governor or have on a couple of occasions they are still stuck back at the Senate or the House. We've spoken on many of them throughout the Legislative Session but there are several that directly affect Will County.

### Will County Legislative Update June 17th, 2010

**HB 1075** – **Illinana Expressway (amendment #3)** Authorizes the State of Illinois to work with the State of Indiana to construct the Illiana Expressway. The new interstate highway will connect I-55 to I-65. Provides for public / private partnership agreements for planning and funding the project.

Placed on Calendar Order of 3<sup>rd</sup> Reading May 3<sup>rd</sup>, 2010

**HB 2369 – American Recovery Bonds - Amendment #3** Provides for the Authority to reallocate recovery zone bond funds and qualified energy bond funds. Waiver of bond allocations is completely voluntary.(previously SB3474) **Passed Both Houses 5-26-2010** 

**HB 4927 – Video Gaming Provisions (Amendment #2)**– Technical changes to the Video Gaming Act. Allows truck stops to operate video gaming terminals around the clock. Gaming Board may also limit establishments based upon undue economic concentration.

Passed Both Houses 5-26-2010

**HB 5483 – Open Meetings Act** – Requires that a public body approve minutes of its meeting within 30 days or its second subsequent regularly scheduled meeting, whichever is later. They must be made available for public inspection once approved. If the public body has a website, they must be posted within 10 days (now 7 days) after approval. Also provides that any person be permitted an opportunity to address public officials at the meetings subject to the Act under rules established and recorded by the public body.

Passed Both Houses 5-26-2010

**HB 5671 – Annexation Notice** A municipality shall give at least 10 days prior written notice of the time and place of the passage of the annexation ordinance to the county when they are force-annexing a parcel that lies within the unincorporated area of the county. **Passed both Houses 4-27-2010 / Sent to Gov 5-26-2010** 

HB 5873 – Pension Reform Changes the actuarial funding level and funding level requirements for the downstate police and fire pension funds. Senate Floor Amendment #3 Postponed – Executive Committee 5-6-2010

**HB 5972 – County CD - Code Hearing Unit** Provides that the county board of any county that establishes a code hearing unit may, by ordinance, establish a fine schedule for code violations.

#### Sent to Gov 5-28-2010

HB 6178 – County Jail Medical Expenses Protects an arresting authority from any financial liability associated with a self-inflicted wound sustained by an arrestee. Restores protection that for municipal governments. Absolves municipal governments of responsibility for the medical expenses of an arrestee for suicide attempts or narcotic ingestion.

Sent to Gov 5-28-2010

HB 6239 – Administrative Adjudication Process The counties of Cook, DuPage, Kane, Lake, McHenry and Will may provide for a system of administrative adjudication of violations of certain county ordinances such as violations of parking, standing, compliance, and automated traffic laws. Sets forth powers and qualifications of hearing officers. Provides for judicial review of administrative decisions. Sent to Gov 6-2-2010

HB 6380 – Joliet Port District Board Increases the board from 9 members to 10 members. The County Executive, with the advice and consent of the Will County Board, shall appoint 6 members of the board. Provides that the Authority shall be abolished upon the last to occur of the following: i) expiration of the 25-year period, ii) one year after all revenue bonds, notes, and other indebtedness of the Authority have been paid or discharged or otherwise provided.

Sent to Gov 5-28-2010

**HJRCA 15 - A Constitutional Amendment** Provides a reduction of county board members to 17 in non-home rule counties by referendum. **Tabled 5-2-2010** 

SB 744 – Gambling - Replaces everything after the enacting clause. Creates the Chicago Casino Development Authority Act. Provides for the creation of the Chicago Casino Development Authority, whose duties include promotion and maintenance of a casino. Amends the Illinois Horse Racing Act of 1975 and the Riverboat Gambling Act to authorize electronic gaming at race tracks (and makes conforming changes in various Acts). Further amends the Illinois Horse Racing Act of 1975. Ends the term of current members of the Illinois Racing Board, and makes various changes concerning the criteria for Board members. Contains provisions concerning testing of horses at county fairs, payments from the Horse Racing Fund, and standard bred horses. Further amends the Riverboat Gambling Act. Changes the short title to the Illinois Gambling Act. Adds 3 additional owners licenses, one of which authorizes the conduct of riverboat or land-based gambling in the City of Chicago. Makes changes in provisions concerning the admission tax and privilege tax. Makes other changes. Effective immediately.

Makes changes in the definition of "electronic gaming"; provides that no organization licensees shall be able to receive payments under the recapture provisions beginning on the January 1 first occurring after the earliest date that any organization licensee begins receiving funds from electronic gaming; adds provisions concerning the award of racing dates; allows thoroughbred organization licensees to petition the Illinois Racing Board to conduct quarter horse racing and receive purse grants from the Quarter Horse Purse Fund and gives the Illinois Racing

Board complete discretion in distributing the Quarter Horse Purse Fund to the petitioning organization licensees; and makes other changes. In the Riverboat Gambling Act (now the Illinois Gambling Act), makes changes in provisions concerning the duties of the Illinois Gaming Board; makes changes in provisions concerning deposits into the Horse Racing Equity Trust Fund, including providing for \$250,000 annually to be distributed to the Quarter Horse Purse Fund; makes changes in language exempting certain owners licensees from admission taxes; and makes other changes.

Passed Both Houses 5-27-2010

SB 1346 – Creates the South Suburban Airport Authority Act and the South Suburban Airport Authority - Contains provisions concerning governance and finances of the Authority. Provides that the Public Funds Statement Publication Act shall not apply to the Authority. Placed on Calendar Order of 3rd Reading March 25, 2010 (remains in Senate)

**SB 1946 Pension Reform** – Makes changes concerning new hire conditions for receiving benefits, calculation of salary, annual increases, survivor's annuities and application of alternative formula provisions. Sets forth a new employer contribution schedule. **PA 96-0889 / 4-14-2010 Effective immediately** 

SB 2529 – Coroner's Fees – Provides for an increase for specific Coroner's fees for the first time in 20 years for autopsy reports, cremation permits, transcripts, toxicology reports and other miscellaneous reports. Fees must be deposited into a special account with the Treasurer. They can only be used to purchase electronic and forensic id equipment, related supplies and for operating expenses of the Coroner's office.

Sent to Gov 5-26-2010

**SB 3085 – Juvenile Jurisdiction Task Force** Shall submit a report of its recommendations to the GA January 1, 2012. Commission shall study the impact, develop timelines, and propose a funding structure for the expansion of the jurisdiction of the Illinois Juvenile Court for youth to include age 17. **Sent to the Gov 5-27-2010** 

**SB 3183 – Gov Ethics – Economic Interests** Permits the County Clerk to send statements of economic interests on an internet-based system for 1) the filing of statements of economic interests and 2) reporting by units of local gov for the names of persons required to file statements with that county clerk. **Sent to Gov 6-1-2010** 

SB 3214 – Joliet Arsenal Development Board Provides that the Board of the Joliet Arsenal Development Authority shall consist of 10 members (now, 9 members). Provides that the County Executive of Will County, with the advice and consent of the Will County Board, shall appoint 6 members of the Board (now, the Will County Board appoints 5 members). Provides that the Authority shall be abolished upon the last to occur of the following: (i) expiration of the 25-year period (now, 15-year period) that began on the effective date of the Act; or (ii) one year after all revenue bonds, notes, and other evidences of indebtedness of the Authority have been fully paid and discharged or otherwise provided for. Sent to Gov 5-21-2010

**SB 3464 – Telecom Company Notice Requirements** Provides among other things, provides that 30 day prior to issuance of a building permit a telecom company must provide written notice of its intent to construct a tower to the State Rep, Senator and **each** county board district representative.

Placed on Calendar Order of Concurrence House Amendment(s) 3, 4 - May 7, 2010

**SB** 3540 – Juvenile Court Fees Among other things, Increases the monthly fee for a minor placed on supervision, probation, or conditional discharge from \$25.00 to \$50.00. Also provides that if a minor is a victim of certain offenses, their identity may be disclosed to appropriate school officials for the purpose of preventing future violence involving minors.

Sent to Gov 6-1-2010

SB 3695 Court Fees for State Police Operations – Among other changes, creates the State Police Operations Assistance Fund which is funded by fees received by court clerks. Provides that if the clerk of the circuit court imposes fees for automated record keeping they shall charge and collect an additional fee in an amount equal to that amount to be paid by the defendant in any felony, traffic, misdemeanor, local ordinance or conservation case upon a guilty judgment or grant of supervision. This will result in a loss of county funds paid out of the \$75.00 vehicle offense bail amount.

Sent to Gov 6-3-2010

SB 3721 – Clean Construction and Demolition Debris- Provides, in several provisions of the Act, that "uncontaminated soil" means soil that does not contain contaminants in concentrations that pose a threat to human health, safety, and the environment, but also authorizes the Illinois Pollution Control Board, by rule, to specify the maximum concentration of contaminants, including a particular carcinogen, benzo(a)pyrene, that may be present in uncontaminated soil. Authorizes the Board to adopt rules for the use of uncontaminated soil and clean construction or demolition debris (CCDD) as fill material at CCDD fill operations (current or former quarries, mines, or other excavations where CCDD is used as fill material), which rules may specify limits on the use of recyclable concrete and asphalt as fill material at those sites. Requires owners and operators of CCDD fill operations and uncontaminated soil fill operations to meet certain requirements, including, among other things, that the owners and operators confirm that the CCDD or uncontaminated soil was not removed from a site subject to certain environmental remediation activities, excepting, however, schools located in a county with a population of more than 3,000,000 that have been required to perform certain environmental testing under the Act. Requires the owners and operators of CCDD fill operations and uncontaminated soil fill operations to maintain certain documents and to make those documents available for inspection by the Agency and units of local government. Specifies the types of materials that may be used as fill material at CCDD fill operations and uncontaminated soil fill operations. Authorizes the Agency to collect a fee from the owners and operators of CCDD fill operations for accepted CCDD and uncontaminated soil, which fees shall be deposited into the Environmental Protection Permit and Inspection Fund. Provides that violations of these provisions are enforceable by administrative citation or as otherwise provided by the Act. Specifies civil penalties for violations of these provisions. Sent to Gov 6-4-2010

SB 3763 – County Highway Relocations - Provides that upon completion of the relocated highway and its opening to public travel, the county shall have full authority over the relocated highway and that portion of the original location not incorporated into the new location (rather than considering it abandoned). The county board may transfer road jurisdiction to another highway authority or vacate, transfer, or sell the property.

Sent to Gov 5-21-2010

Member Goodson ended by saying that Veto Session is scheduled for November 16, 17<sup>th</sup> & 18<sup>th</sup>, 2010. So it remains to be seen whether or not the Legislators will return to Springfield between now and November to address additional budget issues. So if anybody has any questions.

County Executive Walsh asked if there were any questions. Member Konicki...

Member Konicki asked Member Goodson a question on that SB 3721, stating obviously we haggled over this the last County Board meeting; however, I noticed some new information here I wasn't aware of and that's that the owners and operators...reading in the middle of the summary. It says "that the owners and operators confirm that the CCDD, Clean Construction and Demolition Debris, or uncontaminated soil was not removed from a site subject to certain environmental remediation activities, excepting,"...and of course its following the excepting that's the danger..." schools located in a county with a population of more than 3,000,000 that have been required to perform certain environmental testing"...obviously the only County that qualifies is Cook. Do you now happen to know which schools they are talking about and what remediation those schools are subject to? Because those are obviously contaminated materials that we know to be contaminated that are not going to come into our unlined quarries under this Legislation, that's a concern. Do you have any more information on that?

Member Goodson responded Member Konicki I would be happy to check into that. I'm honestly not aware of the schools in Cook County that are subject to this problem. I would be happy to look into it.

Member Konicki stated that I would appreciate that information. Thank you.

County Executive Walsh asked if there were any other questions.

Member Rozak stated I don't have a question, I have a comment. As you can see by this Report, and for many of the members that have been here a long time I just wanted to express my appreciation for all the work you do on this Committee. These bills move constantly and Member Goodson has a handle on this all the time at our meetings. They're ever changing and this was quite a session this last time and I just wanted to express my appreciation because I think Will County has a better handle on what's going on in Springfield. We always seem to have our hands in the situation down there and a lot of it is thanks to our Chairman and I want to give kudos to her.

Member Goodson stated Member Rozak thank you so much. I have to say; obviously we're all aware of what I do revolve around legislation, both in Will County and several groups that are within Will County. But we certainly could not do the work that we do with

the number of bills that pass through the legislature each and every session. I think more than ever, this past session; we recognize the value of having eyes and ears on the ground in Springfield. It is so important, we all have very busy lives and we can't constantly keep an eye on this to the extent that we need to and with Will County being one of the most important Counties in the State of Illinois we have to know what is going on at all times. And I really want to compliment our lobbyist, both Member Maher and Mr. Hassert for work that they did for us in Springfield this past session.

County Executive Walsh stated thank you member Goodson. Any other questions?

### CAPITAL IMPROVEMENTS COMMITTEE Charles Maher, Chairman

Members Maher stated thank you County Executive Walsh, fellow County Board Members. We have our Facility Needs Report that was submitted last month for the people to review and want to entertain any questions from any of the Board Members on this. We do have Mr. Jason Dwyer of Wight & Co. that can help us go through the data if we need to otherwise I'll put it on the floor.

County Executive Walsh asked if anyone had any questions...If Mr. Jason Dwyer would like to come down. If any body has any questions.

Member Maher continued saying and I can appreciate that. There is a lot of data that's going on in here. Most of this is going to be used for the decision making process that's happening after this. And in doing our strategic plan we will be starting to take a look at the scope of that project at our next capital meeting. Do I need to entertain a motion? The Report itself... We're going to place this Report on file. Electronic copies for all Departments and other folks can be obtained from the County Board office. Paper copies, we'll try and do for just the County Board Members at this time. The cost of printing these reports is well over a \$100.00 per Report, where the copy of the electronic disk is about a buck. So if you would like copies of this...many of the departments to be able to see the data please feel free to contact our group. Otherwise we'll start that next process next week.

County Executive Walsh asked if that was available to the general public too.

Member Maher responded I would imagine that it is.

County Executive Walsh asked electronic?

Member Maher responded yes electronic copies only.

WHEREAS, the County Board of Will County, Illinois, has determined that the boundaries of some Election Districts in DUPAGE TOWNSHIP must be readjusted, renumbered, combined, or eliminated in order to better serve the voters of each District, and

WHEREAS, it is necessary that each proposed readjusted, renumbered, combined, or eliminated Election District shall be composed of contiguous territories and that they are in as compact form as can be had for the convenience of electors voting therein, and

WHEREAS, the County Board of Will County is now duly assembled at its regular June 2010 meeting.

NOW, THEREFORE, BE IT RESOLVED, by the County Board of Will County, that in compliance with the aforementioned specifications, the following described Election

Districts in DUPAGE TOWNSHIP be newly readjusted:

#### **DU PAGE PRECINCT #31 (READJUSTED)**

Beginning at the point of intersection of the West Branch of the DuPage River and the North Township line of DuPage Township; thence East along the North Township line to the point of intersection with the East Section line of Section 6; thence South along the East Section line of Section 6 to the point of intersection of Naper Boulevard; thence East and Northeast along the center line of Naper Boulevard to the point of intersection with Arlington Avenue; thence East along the center line of Arlington Avenue to the point of intersection with Barkdoll Road; thence South along the center line of Barkdoll Road to the point of intersection with Royce Road; thence Southwest along the center line of Royce Road to the point of intersection with Naperville Road; thence South along the center line of Naperville Road to the point of intersection with the East Branch of the DuPage River; thence South Westerly along the East Branch of the DuPage River to the point of intersection with the West Township line of DuPage Township; thence North along the West Township Line of DuPage Township to the point of intersection with the West Branch of the DuPage River; thence Northeasterly along the West Branch of the DuPage River; thence Northeasterly along the West Branch of the DuPage River to the point of beginning.

#### ASCERTAINING 2010 PREVAILING WAGE RATES

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, (820 ILCS 130/0.01 et seq.), and

WHEREAS, the aforesaid Act requires that the County Board of Will County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of Will County employed in performing construction of public works for said County.

#### NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD OF WILL COUNTY:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the County of Will is hereby ascertained to be the same as the prevailing wages for construction work in the Will County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the County of Will. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

<u>SECTION 2:</u> Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the County of Will to the extent required by the aforesaid Act.

SECTION 3: The Will County Clerk shall publicly post or keep available for inspection by an interested party in the main office of the County of Will this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

<u>SECTION 4:</u> The Will County Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

<u>SECTION 5:</u> The Will County Clerk shall promptly file a certified copy of this Ordinance with <u>both</u> the Secretary of State Index Division and the Department of Labor of the State of Illinois.

<u>SECTION 6:</u> The Will County Clerk shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
