County Executive Walsh asked Members Winfrey and Goodson to come forward to present a Proclamation Recognizing The 20<sup>th</sup> Anniversary of the Americans with Disabilities Act to Ms. Pam Heavens.

Member Goodson came forward and stated good morning everybody. I just want to give you a little background on this Proclamation today. Today we are recognizing the 20<sup>th</sup> Anniversary of the Americans with Disabilities Act. And basically the Act was established as a clear and comprehensive prohibition of discrimination based on disability. It was signed into law on July 26<sup>th</sup> of 1990 by President George H. Bush and it was later amended effective January 1, 2009. The ADA law prohibits under certain circumstances discrimination based on disability. It affords similar protections against discrimination to Americans with Disabilities as the Civil Rights Act of 1964. The determination of whether any particular condition is considered a disability is made on a case by case basis. Certain specific conditions are excluded such as disabilities such as substance abuse or visual impairment which is correctable by eyeglasses. It is a wide ranging Act but yet there are specific things that are not considered disabilities. As we all know here in Will County, we are very fortunate to have Ms. Pam Heavens with our Will-Grundy Center for Independent Living. She is a perfect example of just…her capabilities are beyond the scope of imagination and we're pleased to be able to be here today to support this as our County supports many different programs for disabled residents. I will let Member Winfrey move ahead with our Proclamation. Member Winfrey stated good morning County Executive Walsh and fellow County Board Members. It's a pleasure to be here today on behalf of the ADA recognizing the 20<sup>th</sup> Anniversary of the Americans with Disabilities Act which will be July 26, 2010 and we have Ms. Pam Heavens accepting this Proclamation on behalf of the ADA. Pam, as some of you know, is the Executive Director for the Center for Independent Living and has done great work in the area of having the disabled community be recognized throughout the area. So on behalf of her and all persons with disabilities and all those people who support that, I offer this Proclamation.

WHEREAS, The Community Development Division (CD Division) of the Will County Land Use Department is responsible for administration of certain Federal and State grant programs allocated to the County under the Housing and Economic Recovery Act of 2008 (HERA) and under the American Recovery and Reinvestment Act of 2009 (ARRA); and

WHEREAS, the CD Division has been charged with the administration, compliance reporting, monitoring and oversight of \$11.5 million in new federal and state Neighborhood Stabilization (NSP) grant program funds from HUD and under HERA and ARRA; and

WHEREAS, it is the responsibility of the Will County Executive to assure the federal and state granting agencies that the County has the demonstrated capacity and ability to adequately meet, enforce and otherwise oversee all grant funds so allocated; and

WHEREAS, the new grant programs and allocations are accompanied by additional administrative, compliance reporting, monitoring, and oversight responsibilities which collectively are in addition to existing and ongoing administrative, compliance reporting, monitoring and oversight responsibilities required by the existing grant programs under the responsibility of the CD Division; and

WHEREAS, the new grant allocations include provision for additional administrative allowance not to exceed 10% of the grant award plus program income generated, all necessary to provide the needed monitoring, reporting and administrative oversight; and

WHEREAS, the CD Division requests that administrative funds be allocated to create a Compliance and Monitoring staff position for the NSP grant program in order to meet the new and increased administrative, compliance reporting, monitoring and oversight responsibilities as required under HERA and ARRA and as required by the U.S. Department of HUD and the State of Illinois.

NOW THEREFORE, BE IT RESOLVED BY THE WILL COUNTY BOARD THAT:

SECTION 1: The Will County Board authorize the creation of one full time staff position for the Compliance and Monitoring staff position as described in the attached Job Description, for the remaining portion of the current fiscal year as follows:

Member Gould stated good morning County Executive Walsh and fellow Board Members. Also our Committee has no resolutions for this month. We'll reconvene in August. Thank you.

County Executive stated thank you Member Gould.

# LEGISLATIVE & POLICY COMMITTEE Lee Goodson, Chairperson

Member Goodson stated good morning County Executive Walsh and fellow County Board Members. I have one Resolution this morning. Resolution #10-250, Opposing HB5055 Re: Civil Law – Tech (Makes a technical change in a Section regarding the short title of the Article re: mortgage foreclosures (Sheriff's Sales).

Basically at this point in time our Will County Sheriff does the foreclosures in the County and all of the Sheriff's sales we do. This legislation essentially changes one part of that in that this now gives the Plaintiff essentially in most cases that being the Bank, the opportunity to make a decision on whether or not to use a private company or this process or our Will County Sheriff. Sheriff Kaupas was good enough to come to our Legislative Committee and explain some of the effects that this will have on our County and basically right now, from what I understand, our process is a well oiled machine. It's a process that's not broke and we don't want it fixed. Right now the foreclosure rate in Will County, we have approximately, last year we had over 2,000 foreclosures. This does generate revenue for the County. \$500.00 per sale and that meant over \$1.5 million for our General Revenue Fund. Foreclosures this year so far are 1,469. We are in line to project that we'll do over 2,500 by the end of this year generating approximately \$2.5 million to our General Revenue Fund. This would take the process out of the hands of the County and privatize it, if the Plaintiff chooses to do that. And some of the changes that I think will affect the owners of these properties is that our Sheriff has a process, a way of going about this in that he definitely takes things into consideration; how is this going to affect the property owners? They take certain things into consideration when serving somebody with these

papers. He doesn't do it on holidays, he doesn't do it in inclement weather, he's able to work with moving companies to assist a property owner in getting their belongings out of a piece of property, and sometimes our process takes 60–90 days. A private company doesn't have this relationship with our residents. They don't have to be from Will County, and they can come in here and basically get somebody out of their place within 5 days. It's a whole different process, a whole different attitude towards our residents and we are strongly opposed to it. Unfortunately this Legislation sailed through the House and through the Senate and it is on the Governors desk as we speak. We are joining our Metro Counties. Several of our Metro Counties have signed letters and sent letters to the Governor requesting that he veto this Bill. And this Resolution basically requests that and it will be accompanied by a letter from the County Board requesting that the Governor veto. General opinion is that on the surface this bill appears to be a pro business bill and that there is a very slim chance that the Governor will veto this bill but we still want to make sure our voices are heard.

Member Gould stated I just wanted to say that after practicing law for a lot of years I know that the Sheriff has been very sensitive to people who find themselves in a situation of foreclosure. Particularly when they are served and they have to move and you can compare that to a situation that happens in Chicago versus when that happens in Will County. And as Member Goodson pointed out; the system is not broke and why try to fix it. In my opinion it has worked well for a number of years. The Sheriff has shown great sensitivity and I think we should support this Resolution.

Member Moustis stated I agree with everything that has been said. The method we have now brings uniformity to the entire County, so everyone is treated in the same manner. If this goes to the private sector, who can know many of these folks doing this may be 20-30 and you would not have the consistency I think you would like to see throughout our County. I feel strongly that we have to ask the Governor to veto this. I believe the County Executive and feel free to speak back up; I believe you've already talked to the Governor's office. I appreciate that on behalf of all the folks that have had hard times in Will County, but I do think that the system we currently have needs to stay in place.

Member Rozak stated I also think it's a public safety issue. I think the situation is volatile enough when someone goes out there but I think it is a much better situation when a uniformed law enforcement officer is going out to the area. And also it's a trickle down effect with the newspapers. According to what I see and I don't see that this has to be published in the general circulated area in our area it could be published anywhere. You see all the foreclosures published in the Labor Record, Farm Bureau or a little town newspaper. And it will have an affect on them also.

County Executive Walsh stated thank you Member Rozak, very good point.

Member Traynere stated just one other point County Executive Walsh, when this private sector company is very successful and they go in and they go out to do the foreclosure, what's to stop them from calling our Sheriff's Department to accompany them? So we're going to expend the funds for the labor anyway.

Member Adamic stated I agree with everything that has been said. Member Rozak pretty much hit on the point that I was going to make. It just doesn't affect everything else that

has been said with regards to the foreclosures and getting all that done. With regards to the newspaper revenues losing out on the source, especially our locals, the Herald News, the Times Weekly, Farmers Weekly Review and the Labor Record and so forth and all the other ones that are out there. There is a source of revenue that they rely on and that may dry out for them so there is that business component too as well. I would strongly urge the Governor veto this as well.

Member Konicki stated I think it's very important that the process...it's a very traumatic process when it comes and I think it's imperative that it be conducted with a certain amount of decency, compassion, also consistency and predictability. I think that's only fair. The fear I have is not only for those going through foreclosure but for those going through an eviction from their apartments for inability to keep up with their rent payments. And that's probably even a much larger market. I think this is the first step in that larger direction. I think we all read in the newspaper when the Sheriff of Cook County when his conscious was so shocked by some of the circumstances that he temporarily suspended and he adopted an internal policy of not putting people to the curb during vicious weather or during the holidays. That kind of thing eliminates pressure on him to do it. I think the push for this is coming, probably on the Cook County (inaudible) because there is pressure from the other side of the issue here. You can be thoroughly ruthless and perhaps overly efficient; overly efficient to the point being...in a sense violating the conscious of us as all that we hold as a society, a push in that direction. And, I think this would certainly do it in a mortgage foreclosure realm. But I'm just telling you there is a much larger agenda here that we would see this happening even for the eviction process from apartments. So it is very important that this be stopped and any personal lines of communication from our Governor. I firmly believe that if he understood the ramifications of this legislation on people will be affected, the ones being moved to the curb, he will never sign it. It's not who he is as a Governor, a person or as a politician. But I was stunned when Member Goodson mentioned this morning that her information is he ready to sign it. So I think it's quite stoppable if he understands and I know that you have direct communication with him and I want to ask you to make sure he understands the full ramification. This is not (inaudible) this is something other than pro business. I think if he understands that he will not sign it he will veto it.

- *(i)* any person who had been appointed pursuant to section 15-1506 by any circuit court in any matter prior to the effective date of this amendatory Act of the 96<sup>th</sup> General Assembly,
- (ii) any judge, or
- (iii) the sheriff of the county in which the real estate is located.

**WHEREAS**, the Office of the Will County Sheriff managed the sale of 2,011 foreclosed properties in calendar year 2009; and

**WHEREAS**, the Office of the Will County Sheriff has thus far managed the sale of 1,469 foreclosed properties in calendar year 2010 and projects total foreclosures for said year to total 2,500; and

**WHEREAS**, the Office of the Will County Sheriff has consistently managed the sale of foreclosed properties in Will County efficiently, diligently and with fairness to all parties for several decades.

**NOW, THEREFORE, BE IT RESOLVED**, that the Will County Board hereby **OPPOSES HB5055**, which amends the Mortgage Foreclosure Article of the Code of Civil procedure and requests that Illinois Governor Pat Quinn veto said legislation because its application statewide, and to Will County Illinois in particular, serves no substantial public policy purpose, and diminishes an established, fair and equitable system for the sale of judicial properties.
