TRANSPORTATION STUDY REPORT FROM CDM SMITH IS MOVED FROM THE EXECUTIVE COMMITTEE TO THE BEGINNING OF THE AGENDA.

Member Moustis stated CDM Smith is with us today and will go through a ten to fifteen minute presentation here.

County Executive Walsh stated thank you very much.

Mr. Carl Fry, stated thank you very much as well. My name is Carl Fry; I am the Client Services Manager with CDM Smith. Our offices are in Lisle, Illinois and Chicago and we have 6,000 employees around the world. Last fall the County retained us to prepare a preliminary study of the infrastructure needs around the Cook County In-Land Ports. I have just a few slides and a very brief summary of the results of that report. It is my understanding that we have a few final comments to resolve and then the report will be released to the public shortly; probably next week.

Mr. Fry gave a presentation, a copy of which has been placed on file with the County Clerk's Office.

Member Kusta arrived at 9:53 a.m.

Mr. Fry stated that really concludes my presentation, we really enjoyed working on this project and I really got a lot out of it. I hope you will consider some of these recommendations and move forward with this. Clearly, the In-Land Port is an important economic generator for Will County and anything that we can do and work with you to facilitate that growth and future development is going to benefit everyone.

County Executive Walsh stated thank you Mr. Fry.

Member Moustis stated I would just like to first, everyone has a disk with the full report on it. It is more interesting reading than you might think. So take a look at it. The report talks about a lot more detail, you are getting the "Readers Digest" version of the "Readers Digest" version. So take time to look at it. This will be distributed to all the stakeholders, both public and private. I think it is the intent of the County Executive to call a stakeholders meeting together. Which, by the way, the Board or anyone who is interested can come to those meetings, if you want to have additional input or comment. I think that pretty much probably covers how we are going to go forward. I believe we are going to start with the CED tomorrow at their meeting and then, I think, our public stakeholders will be brought together. It will be distributed and I would think County Executive Walsh, that we are going to distribute this immediately to the Road District on any of these; the municipalities that have expressed an interest. Hopefully, we would get it over to them pretty quickly.

County Executive Walsh responded as soon as it is ready for public distribution, then all of those entities will be given and Mr. Carl Fry met with a huge number of these governmental entities and it will be their responsibility to get that out once after...you know, everybody will be getting one.

Member Moustis stated, the reason I mention that is if this is going to be at the CED meeting tomorrow morning then I think that everyone should be...it should be distributed to everybody. It should not just be specific to them.

County Executive Walsh responded I don't know if they are going to get anything more than what maybe you got. Is there more on tomorrow?

Mr. Fry responded I think the only thing that we plan to do tomorrow is I am going to give this same presentation and offer to answer questions. We did receive some final comments on the report yesterday.

Member Moustis stated so this (inaudible) I know you mentioned this to me before the meeting, there are going to be some small additional changes, information and then when it is completed it will be distributed. When is that?

Mr. Fry responded next week.

Member Moustis stated next week. So it will be distributed to everybody at the same time next week.

County Executive Walsh responded yes. Nobody will be getting anything other than when it is final, then it will be distributed to everybody.

Member Moustis stated okay, I'm just wondering because we don't meet for another month. So our version...there could be some changes to the version we received?

Mr. Fry responded very minor. It is just there are a few minor comments.

Member Moustis asked will those be e-mailed to us telling us the changes. I don't know, I am just asking. Since we have something here, and there might be some changes, you will distribute the addendum to us on the changes.

County Executive Walsh stated put it on the website that these are the changes. Somehow indicate...

Mr. Fry responded we will distribute it to the County Board Members. Whether we send out CD's or whatever.

Member Moustis stated I don't want to complicate this. So we should have the distribution to all the stakeholders.

Mr. Fry responded yes.

Member Moustis stated thank you. Part of the reason I am mentioning this, is because occasionally and County Executive Walsh I am sure you are asked also, people keep asking "when are they going to receive it". I keep telling them soon.

County Executive Walsh stated yes I have been asked by a number of them already and I am sure Mr. Greuling has also been probably asked and once it is ready and completed, their study is basically...the report is completed that is when everyone at one time at the same time will be getting a finished copy.

Member Moustis stated very good.

Member Maher asked what challenges do you see going to a weight fee structure?

Mr. Fry responded well clearly, absent State legislation it could be difficult to follow if the units of government aren't on board with that suggestion. That is really the challenge we see from a technological standpoint, from a calculation standpoint it is not an issue. Something could be put together, we have worked with agencies around the Country where you could have a website where a shipper would go to one location and indentify the route he is going to travel and get all the permits that he needs in one location. It is not necessarily a simple permit, it is just a single point to go to, to get the necessary permits.

Member Maher asked if it is all self reported on weight and everything?

Mr. Fry responded that is the way that permits are generally issued. You self report what your weight is, what is your length and any other items that need to be permitted and then you have the permit in your vehicle and it is up to law enforcement to make sure that the vehicle is in accordance with the permit.

Member Rozak stated on the CD here is it showing who all the stakeholders were that were involved?

Mr. Fry responded I think there is an appendix on the CD that lists all the stakeholders who were present at the various meetings.

Member Rozak asked who represented us? Who was that?

County Executive Walsh responded I was.

Member Rozak stated you were, okay.

County Executive Walsh continued Mr. Bruce Friefeld was there.

Member Rozak continued like Member Moustis said could we be notified when they do, do that Committee.

County Executive Walsh responded absolutely. There is no hidden agenda here.

Member Rozak stated no, no I was not...I was just wondering. What I was concerned, I just wanted to make sure...

County Executive Walsh stated basically this was an issue that was brought up by Senator A.J. Wilhelmi and the issue was that there was the availability of a grant but it had to come from a governmental entity and Will County was the logical choice to apply for this grant, which we did and...I understand Member Rozak. But everybody that is listed, the one meeting that Senator Wilhelmi had had 83 or 85 stakeholders sitting around the table and all of them and the governmental entities who were there also around the table and people from as far away as Peoria to Chicago were also involved and many of the trucking industry's companies that operate out of the intermodals right now were there so everybody will be given the opportunity and time wise we are probably looking at late June, probably after the June County Board meeting of bringing the stakeholders together for Mr. Fry and his group to present as detailed of a program and presentation as they want to make.

Mr. Fry stated actually, making that presentation will be Mr. Mark Berndt who is the leader of our national freight practice. Mr. Berndt's office is up in St. Paul, Minnesota; but he will be coming down for that presentation because he was most directly involved in this project.

Member May stated can I ask to what is the end result, what will be the conclusion of...

Mr. Fry answered well we identified our recommendations, as I said this is kind of a preliminary study that really identifies what the problem is; what the future issues may be; and really try to gather stakeholder input so that we can move forward, so that the County can move forward with a plan. But really there is no...other than the reports there is no...

Member May stated which plan the County's or the State's plan? The County's plan or the State's? This is up to the County?

County Executive Walsh responded no this is...they took all of the input that came from basically meeting with the stakeholders and they met for six weeks or whatever it was, and took those comments and tried to put them in some form of a presentation to say here is what everybody is thinking and they using their expertise of saying here are some alternatives or some proposals on how to accomplish what is being discussed or what the concerns are. This is not the County's plan this is a gathering of data and putting it out here to us and saying here it is and possibly more than anything would help a legislator if there was a move to try and put something together as far as a piece of legislation which I am almost sure it would have to be in order to get it accomplished. Because, as he said trying to find one central point of assessing a weight limit price tag as far as a fee, unless it comes from the legislation as a law I doubt very much if it would be accomplished.

Member May continued so County Executive Walsh if all the yeas and nays together and then (inaudible) the State Legislators.

County Executive Walsh stated I would think it would probably have to be that way Member May unless there was one unbelievable kumbaya where everybody would come together and say we want to solve this locally amongst ourselves.

Member May stated I don't see the kumbaya.

Mr. Fry stated you can do a lot with intergovernmental agreements but getting the governments to agree is the...

County Executive Walsh asked any last questions before we move on? Thank you very much Mr. Fry we appreciate it very much your time.

WHEREAS, the County of Will has enacted the Will County Historic Preservation Ordinance, adopted September 17, 1992, and providing for the creation of the Will County Historic Preservation Commission, and

WHEREAS, there exists a church that is deemed significant located at 27942 South 88th Avenue, Peotone, Illinois, 60468, P.I.N: 17-20-03-200-003-0000, and

WHEREAS, the Will County Historic Preservation Commission has the authority to recommend to the Will County Board that the subject property be included on the Will County Register of Historic Places, and

WHEREAS, the Will County Historic Preservation Commission further has the authority pursuant to the Will County Historic Preservation Ordinance, Article IV, to recommend to the Will County Board, properties suitable to be designated as historic landmarks, and

WHEREAS, the property is historically known as St. Johannes Evangelische Gemeinde and commonly known as St. John United Church of Christ, and

WHEREAS, a public hearing was duly held on April 4, 2012, and

WHEREAS, on April 4, 2012, the Will County Historic Preservation Commission voted to recommend landmark designation to the Will County Board for the subject property, and

WHEREAS, the Land Use and Development Committee recommends approval of this request.

NOW, THEREFORE, BE IT RESOLVED, by the Will County Board as follows:

We had a subcommittee meeting on Tuesday, concerning the comments from the Renewing Will County Zoning Ordinance update. There were two public hearings on April 30th and May 3rd and we tried to address all of the concerns that were brought up. One of them was horse stables and reducing the amount of parking requirements and reducing the limits on air turbines on agricultural property. As far as (inaudible) dealers there were a number of comments there and they expanded the firearms dealers to be a permitted use in I-1 and I-2 districts and indoor shooting ranges need a Special Use in A-1 district a permitted use in C-3 and C-4 and I-1 and I-2. We discussed it and it has to meet requirements for PUDs for green buildings and increase that to 33 percent, although I understand Member Moustis would like to address that some more with future discussions. There was also compliance reviews for zoning applications. The present regulation requires 14 days for Land Use to review and they are reducing that to seven business days. There were questions concerning the donation and collection drop boxes; we did not recommend any changes that we presently had in our Ordinance. Also there was a request to change dynamic display advertising set backs from residential and we did not recommend any changes in our present Ordinance for that. The use of cargo containers for agricultural production we are reducing the restrictions on that. We assigned requirements for farms which have test plats we are removing the requirement that they get a Special Use Permit for that. That is basically some of the major (inaudible) that have been changed. We will have a Committee of the Whole next month and bring it up for adoption in June. More detailed information is available on Will County Land Use www.willcountyrenewing@willcountyillinois.com if you would like more information.

LEGISLATIVE & POLICY COMMITTEE Lee Goodson, Chairperson

Member Goodson stated good morning everyone. Fourteen days until the end of Session and counting. Springfield's focus continues to be budget issues and filling the shortfalls and (inaudible). Last week Speaker Madigan, amended House Bill 3637 with three different amendments. All three of them would have offered the diversion of a substantial amount of revenue from the corporate personal property replacement tax; away from all the local government and giving it to the Teacher Retirement Fund. The CPPRT taxes are collected by the State on behalf of local governments to replace local revenues that are lost when the Legislature abolished business and personal property tax. Municipalities receive about 20 percent, schools receive about 60 percent of this money and other local governments, like us, receive about 20 percent of the money. Each amendment would have diverted millions of dollars from either the school districts or from the local government or from other local governments. Basically, as of late yesterday, I did received an e-mail saying that for the time being, this option is off the table. Some other ideas that have come up for new revenues was to divert State tax to the General Revenue Fund and this basically has not been assigned to any Bills right now, but the Counties that went to Metro-Counties all got their figures together so we have been lobbying against this

particular proposal as well. Some other ideas that they have come up with are ones that we heard before to discontinue rebating retail sales tax to the municipalities, increasing the cigarette tax, fund sweeps, these are all the new ideas they have come up with so far. So what happens remains to be seen, but I do think it is interesting that when Speaker Madigan wants to send a message, typically he doesn't do it with his words; he introduces some Legislation to get our attention and get involved with the process. So I give him a lot of credit, he is quite the task master. Some other good news, the House Joint Resolution Constitutional Amendment, number 49, has passed both Houses. This basically, requires three-fifths majority of all Members of Governing bodies in order to increase any pension or annuity benefits to any official, or employee, or appointee; it is going to require a majority three-fifths vote. As voters, this will also be on our ballot November 6th. So now that it has passed both Houses as voters, as residents of the State of Illinois we will have the opportunity to weigh in on this and say whether or not we agree with it, so don't miss that one on your ballot.

Senate Bill 1313, this brings an end to the free health insurance benefits for retired State employees. There is currently over 78,000 retirees that don't pay a premium for their health insurance. Health care costs for this are expected to exceed \$800 million because the premium won't address that as the total amount of the obligation, currently; and so this would...the Director of Central Management Services would be able to determine the rules for this; the rules for the contributions that would be filed with JCAR, the Joint Committee on Administrative Rules. The proposal I am hearing is contributions will be a percentage of health care costs on a sliding scale and they will be based on the length of service as well as the ability to pay and the pension level. It addresses all five of the State pensions and I don't think that it is unusual to pay a premium for your health insurance, I know we all do. I think that is probably a positive thing, there are arguments on both sides, whether or not this is constitutional and I guess it remains to be seen what will happen and it will probably play out in the courts.

One other piece of good news is, Probation Funding. This is something that we have been talking about in our County for quite sometime. It has been underfunded for at least 10 years and then add the pressures of other mandates such as the Cindy Bishop Bill and Counties across the State are forced to make cuts, increase case loads or both. Many components of Probation are mandated by the Legislature and \$95 million is the statutory budget requirement. Probation services have been underfunded for a long time. The Illinois Supreme Court Justice, Thomas Kilbride is pressuring the General Assembly to fund Probation to the statutory required level and at this point, that amount of money is in the budget so it remains to be seen if it stays there. I guess anything could happen, but provided that they are able to come up with money for the Medicaid cut and budget shortfalls, it should stay where it is. So I guess we will keep an eye on that.

Moving beyond the budget, I said that I would give a few minutes to our County Clerk Nancy Voots, because we some issues ahead for our next local election.

County Clerk Voots stated first of all we have to get through the November Election. But we already have the calendar for the April Election. Our Legislators changed the Election date for Passover, but they didn't take into consideration us Catholics because the Election will be during Good Friday and Easter Sunday. I have 30 sites throughout the County that conduct Early Voting and I have been working with the Townships, the Cities and the Villages and they have already informed me that they are not going to be open on Good Friday. That means my office will be open on Good Friday, Holy Saturday and Easter Sunday. My concern is always, and as the

County Clerk, my job is to encourage voter turnout. In the last Election in 2009, we only had 18 percent of people come out and vote. So if our last weekend for Early Voting is going to be going on, on Good Friday, Holy Saturday and Easter Sunday guess what, the turnout is going to be lower. So since I got a hold of the calendar dates, I have already been informing all of you County Board Members, our Legislators, Townships, Cities, Mayors and everybody and I really encourage you to work with your Legislators and talk to them and see if we can get these dates amended. Because even the last Election, was a Primary for President, on Sunday I worked that day, and we had only ten voters and guess what, I was one of them. So really only nine. But it is true, I am there so I see what is happening and I really want people to come out and vote, because we spend as much money if we have 100 percent or the lower turnout. So we really need to get these dates changed and think of all of our religions out there too, not only Passover, but Catholics and encourage people to vote. It is very important and that is my job and I really want to work together and I know most of you I have been talking to and I have been talking to the Townships and if you guys could help me out and write to your Legislators or give them a call I would really appreciate it. Any questions?

Also, by law we have to send our waivers and authorizations to our Townships and Villages that are conducting Early Voting and they are due in July. That is why I am trying to work on this now so when they get their date set, we have to educate our voters because I also do a Voters Information Guide that goes to one per household and it gives them their polling place, the hours of voting and it also gives them their Early Voting sites and the hours that they conduct voting. So I am always going to follow the law that is number one; so if they don't change the law, I will be open, but I am really worried about my Local Clerk sites. I appreciate your help.

Member Goodson stated thank you County Clerk Voots. There is memo in everybody's box. If you haven't already received it, there is a memo in box outlining this issue. If you can, please contact your Representatives and Senators and let them know that we need to find a better answer for moving the Election Date.

County Clerk Voots stated I also thought it would be a good idea too because people don't come out on Sundays I always encourage that maybe we would stay open some evenings, because on the way home from work they could come and vote, like after work, after 4:30 we would be open a couple of nights until 7:00, so I don't want to discourage voting, I just want to change the hours instead of that weekend, we would be working those evenings instead for this particular Election coming up. That's my point.

Member Goodson stated thank you.

County Executive Walsh stated let me ask a question County Clerk Voots, aren't you authorized to be open any evening hours on your own.

County Clerk Voots responded no; the last day by statute we have to be open is the last day to register to vote and we have to be open until 6:00; or the last day you can file your petitions we have to be open, but the statute doesn't require. By statute, we are suppose to be open so many hours during the weekend, that is why we are here on Saturdays and Sundays, but that is why I am trying to work with our Legislators because I think it is more important to be open during the evening than on Sundays, because that is a family day and people go to church and spend time with their families.

Just so you know, we were never in really in negotiations. It was really discussions with the City on how we may want to pursue our various interests, that is what that was about. So it

was the City that at one point was going to negotiate it, they are no longer going to do that so now we are going to do it.

Member Babich continued the discussion was that we would have everything that... that we would tear the First Midwest Bank building down, build a parking deck and we could build a big enough building to house all of our different departments and even selling off the old bank building where our State's Attorney's Office is now, this was all in that discussion back then.

County Executive Walsh stated still is.

Member Moustis stated you know those discussions still go on.

Member Babich stated I hope we can get something to fulfill our dreams that we would want to have done downtown.

County Executive Walsh stated I am sure you are going to see some progress made.

Member Argoudelis stated I have a couple of questions. I know several months ago we talked about, I know we hired a company to take a look at the Pioneer Building as well. Have we ever gotten...

Member Moustis stated the Pioneer Building is off the table. We will not be pursuing it.

Member Argoudelis stated so we got a report on that?

So one of the things we felt was in purchasing the Social Security Building we could actually pay off that building within four years with the rents and not have any debt at all from that. So we would be in a debt free building, the Social Security Building to be able to start using that...because once you start moving, once you start tearing buildings down and rearranging floors you have to put the people places and so this is a huge chess game that needs to take place for us to get where we want to be and the Wight study is the outcome of that chess game and now we need to start putting our pieces where they belong.

Member Argoudelis asked were these potential purchases part of the Wight study?

Member Maher stated the Wight study was never set up to give us potential purposes and plans point by point activity. What they were was a study to be able to show where our strengths and weaknesses were throughout the County and to provide some direction on where we could be in 40 years. In order to do that, we have to have intermediate short term goals, so part of the Wight study was to help us develop a long term picture so that the Committees and the Board could now start doing short term plans.
