## JUDICIAL COMMITTEE Anne Dralle, Chairperson

Member Dralle stated good morning everyone. I have a very brief update on the Adjudication Process, that as every knows we worked for quite a long time. Our first hearing will officially take place July 9<sup>th</sup>, starting at 2:00 in the afternoon in the County Board Office. So if anyone is interested in watching the process, please take the time to attend. There will be a very, very brief meeting of the Women's Caucus right after County Board, which will take five or ten minutes. We have some prior business to attend to, so I hope everybody can stay for a couple of minutes after that. That's all I have. Thank you.

## PUBLIC HEALTH & SAFETY COMMITTEE Don Gould, Chairman

Member Gould stated good morning County Executive Walsh. I have no report, the Sunny Hill items are under the Executive Committee this month.

## LEGISLATIVE & POLICY COMMITTEE Lee Goodson, Chairperson

Member Goodson stated good morning everybody. Springfield has adjourned and just recently over the last couple of days we have heard two major announcements from the House Speaker, if you have been listening to the news. The first one being that the Governor has made his final decision on the closure of the State facilities and he has confirmed that he will be closing five correctional centers and one juvenile detention center by August 31<sup>st</sup> of this year. The IYC, Joliet will not close until October 31<sup>st</sup> and this move is expected to save about \$62 million in the State budget. Member Bilotta you asked earlier what the five facilities were that they are closing. That would be Tamms Correctional Center, Dwight Correctional Center,

Southern Illinois ATC, Decatur ATC and West Side ATC. So we will see what happens with IYC, Joliet moving forward. I am not exactly sure what the decision means to us with the delay in the closure of the Joliet Facility, but hopefully that is good news for us.

Also, the State has hired an Actuary. The Actuary's first day on the job was yesterday and the Illinois Policy Institute reported that not only is there an \$83 billion hole in the pension for the State, but there is also a local liability and the two combined, what that means to us as taxpayers is about \$203 billion or \$41,000.00 per household. I guess when we look at the State problems it still remains to be the \$83 billion, but we get to address the local shortfall and so that is something that we will have to look at down the road.

During the session, they also made some very tough decisions, I think that we have to say our Legislators worked hard this past session and made some of the tough calls that they have to make in order to bring Illinois back in line. There are still a lot of tough decisions ahead, but some pieces of Legislation that they did pass, another gaming extension package passed. The Bill includes allowing a casino in Chicago, Rockford, Danville, Park City and the South suburbs. Slot machines will be permitted at horse racing facilities. That Bill does exempt Home Rule Power for the regulation of the slot machines at horse racing facilities. The State Video Gaming Act has to be implemented prior to any of these gambling activities to be authorized. One major change is that this expansion package versus last years is that it does not allow for video gaming at airports.

Financial decisions that the State has made, there was a tax increase on cigarettes and the tax is now \$1.98 per pack of cigarettes. The second is the probation funding, we had originally sought, they had appropriated the full \$95 million amount for our probation funding, which is great news for us. But when it was all said and done, they reduced that amount to \$47 million, which is 13 percent lower than last year's amount. Hopefully, as we saw last year additional funds will be appropriated to that probation fund and we will continue to tread the water for probation this year.

The pensions, there was no agreement on the \$83 billion for the public pension liability. A special Legislative Session will be held later this summer. The current proposal being discussed would give current employees and retirees two options: One would be to keep their retiree healthcare and accept a lower cost of living adjustment; the second would be to keep the cost of living adjustment and lose post-retirement health benefits. Those that elected to keep the cost of living increase would lock in their current salary for the pension calculations. The Senate also passed SB1313, which ended the free health insurance benefit for the retirees and that will be a significant savings as well. There are approximately 85,000 employees currently receiving premium free healthcare.

A number of other Bills that are pertinent to Will County did pass. There were some changes made to the personal property replacement tax to pay the Regional Superintendent of Schools that was extended until 2013, which means about \$13 million less will be received by the local units of Government.

The Enterprise Zone has passed both Houses, not signed by the Governor yet, but it makes improvements on the (inaudible) Economic Development and it extends the current Enterprise Zones by 25 years. It will require performance and reviews midpoint.

The Tinley Park Mental Health Facility is...the closure is moving forward. The closing date is scheduled for July  $2^{nd}$ . But there are currently no plans to replace the patients that will be displaced by that closure.

One final piece of good news, County nursing homes...Metro Counties, one of the Associations that we belong to has negotiated an agreement with the Comptroller and the Governor's Office, starting July 1<sup>st</sup>, we are going to see the same payment cycle status as the "safety net hospitals". The Comptroller said the nursing home vouchers will be placed on the top of the pile and this is going to benefit not only our nursing home, but approximately 24 around the State.

At the Federal level, the thing that I wanted to mention is that the SAFETEA-LU there has been a Conference Committee meeting to talk about an extension of that SAFETEA-LU Transportation Bill. They are getting much closer to agreeing on both sides, they are looking at a potential of a six month extension again before passing the full blown Bill. We have also received many grant possibilities through our Lobbyist at the Federal Level, Mr. Brett Larson has been unbelievable forwarding the number of grant opportunities that have come to his attention that will benefit Will County.

I am not sure if I missed anything, but if anyone has any questions about anything in particular, let me know.

Member Gould stated, just one correction with respect to Tinley Park. No new patients are being admitted to Tinley Park right now, but the County Health Department is going to receive a year of grant funds and it is probably foreseeing that most of the patients in Will County will go to Provena St. Mary's in Kankakee. There are about ten hospitals in South Suburban Cook area and so forth, but most of them will probably go to Provena St. Mary's in Kankakee.

County Executive Walsh asked will that be the current patients that a patients of Tinley Park?

Member Gould stated I would defer to Mr. John Cicero on that because I don't know with the closure date, what the actual people who are at Tinley right now. I think those will go to Madden. Where is Madden located?

Mr. Cicero answered it is located up near Loyola University Medical Center.

Member Gould continued there is a State facility at Madden that those patients would be...

County Executive Walsh stated Mr. Cicero why don't you come down and just give us a brief...

Member Gould continued I didn't want to leave the impression that there is no plan at all when...

County Executive Walsh stated to address what is already being done.

Member Gould stated Madden I believe...I don't know what town it is located in.

Mr. Cicero stated that is in Maywood that would be near the VA clinic and Loyola University. The Health Department did receive and accept a contract from the State of Illinois, Department of Mental Health for what they are calling Community Reinvestment Services to handle patients that may have formerly gone to Tinley Park. Our Board of Health approved and accepted that grant. Actually, I can tell you that I found out this morning we have received our first payment on that for the month of June. It is a 13 month grant starting on June 1 of this year to June 30 of next year, so we will be receiving one thirteenth of the grant each month and the first payment did come in. Services of admissions stopped this past Monday, the 18<sup>th</sup> at Tinley. Closure is set for that July date and our Health Department has already gone out and basically serviced two or three individuals that were at our local emergency rooms. They were screened and they were deflected to, as Member Gould said, to Provena St. Mary's in Kankakee, which is one of the hospitals that has signed on to be able to provide in-patient services. So the system is already working. We are screening, we are determining whether in-patient care is needed, and if so, they are going to one of the community hospitals that have signed up to provide the services. Madden Mental Health Center is also going to be receiving individuals that may not have other options, so that is another State run facility, which was like Tinley. Our understanding is that they will be expanding, they have some wings that will be, kind of put back into service, if you will, to provide more services and to allow for more beds.

County Executive Walsh asked how would Will County patients get to Madden?

Mr. Cicero stated there is an arrangement with the State, that once our screeners appear at one of our local emergency rooms and screen the patient, if they need to be transported and be hospitalized, there is a transportation company, under contract by the State. So there is a number that we, our screeners would call, they would be transported under a State contract.

County Executive Walsh replied very good.

Member Brooks stated Mr. Cicero, how much is the total amount of the grant for the year? Secondly, when that grant ends, then what happens to these patients?

Mr. Cicero replied the grant totals approximately \$830,000.00 for 13 months, so it is around \$60,000.00 a month that we will be receiving. The first year, our understanding is, it is a grant based program. So in other words, we will be receiving one thirteenth of the grant each month. After the first year, it will switch over to a fee for service basis. So there will be a value for each screening and assessment we conduct at an emergency room. There will be a value for the services that we render at our mental health out-patient center. Remember, once the clients are screened and if there is a need for hospitalization, they will be stabilized, the goal is to put them back into community out-patient services, such as our mental health clinic. Then there is a capitated rate for that service as well. A lot of this is going to be influx because we don't know the actual number of patients that we are going to be screening, so we will be working after the first year to determine what those numbers will be.

Member Brooks asked do you feel those monies that almost \$900,000.00 will be monies enough to service all of these patients?

Mr. Cicero replied well that \$800,000.00 and some was based on a historical number of patients from Will County that were admitted to Tinley. So that is how the number was arrived at, based on historical statistics on how many Will County residents were seeking services at Tinley. Our Mental Health Director felt that it was a good number to get started with, and we are going to see how it takes us forward.

Member Winfrey asked Mr. Cicero when you say it goes to fee for service in the next year, does that mean that Medicaid covers those who may not have private insurance?

Mr. Cicero replied no it is not, my understanding is that it is not Medicaid or Medicare, it would be a fee for service that the State of Illinois would pay for these uninsured folks, based on a pre-determined rate per person. A lot of that is still to be worked out. We got into this with the understanding that it is a work in progress; it is going to be a very dynamic system as we go through this first year. But, we were pleased to have, what we felt was a very good grant amount getting started. Our Board of Health approved some new hires, we are going to be starting very slowly, we are going to be using some existing staff, some existing budgeted positions and we will be adding as we move forward.

Member Dralle asked is Madden as residential as Tinley?

Mr. Cicero answered yes. Madden is a comparable State operated facility as Tinley Park. I don't have all the details about what may be different about Tinley than Madden.

Member Dralle asked can we feel somewhat confident that the individuals that end up at Provena St. Mary's or if they come through our system will eventually be placed at Madden?

Mr. Cicero answered that is my understanding. After they are stabilized at the community hospital that has a contract with the State, that if there is longer term admissions that are needed, that Madden would be the location.

County Executive Walsh stated thank you very much Mr. Cicero for bringing that information up.

Member Goodson stated one thing that I did want to make sure I mentioned, I want to say thank you to Member Gould and to Mr. Cicero for bringing that to our attention, because that is great to hear. I did want to mention that we have been talking about the Construction and Demolition Debris and some legislation that was passed a couple of years ago, has been going through the rule making process which we have been actively involved in, their decision has passed the Pollution Control Board and in what they passed, they did not include ground water monitoring, which is something that we feel is very important to Will County and our residents. Even outside of Will County, because water does not just say within the boundaries of Counties or States for that matter. These rules will be going to JCAR, this is a group of Legislators that will be reviewing this. Unfortunately, they don't have the authority to actually change the rules, what they have the authority to do is go back to the Pollution Control Board and ask them to make certain changes in the rules, but if we can't get a Resolution through JCAR, then Will County will be moving forward and possibly we may have to file a lawsuit to make sure that we protect the citizens of Illinois and Will County. So we will see as we move forward, it seems like a reasonable request even the Attorney General's Office is with Will

County on this. So we are not alone in the fight and we will continue to ask for the protection that we need. Thank you.

Member Moustis stated I might also add that the IEPA is also recommending ground water monitoring. So basically the agency of the Environmental Protection Agency has recommended that water monitoring should be part of the regulations, the Pollution Control Board, a politically appointed board, basically did not let that go forward. So I do think it is something that we need to strongly object to. Will County is dependent on our ground water. The other interesting part, the Pollution Control Board basically used the justification that it was too expensive. They accepted a number that came from the quarry industry as far as I can see without any real back up or data and the number that was given to the Pollution Control Board, that they accepted obviously, I think was grossly inflated. But, even for them to make a decision that they would potentially put our underground water at risk and help the residents of Will County and elsewhere because of money is absurd to me. The cost we believe is not that much and so this is, I think, Illinois politics at its worst. Basically, residents being sold out, so I am hoping that JCAR will see this. Even that if it is sent back, the guarry industry is still the winner, they win regardless because the rules still don't apply. Which means they still don't have to monitor the underground water. I really think that we need to go forward and perhaps see if we can just stop the activity period until the rules are strongly in place and include underground water monitoring. I just wanted to say this is an issue and I would ask everyone in this room, everyone who listens to this meeting, please call your Legislators, send letters, we should be strongly objecting to this, without the protection of the monitoring of the water.

Member Konicki stated I think Member Moustis feels that the residents are being sold out. It surprises me that usually there is a broader out cry when residents are getting the short end. You have the Pollution Control Board and it is being opposed by the IPEA, the Attorney General, our County, the Legislators, I mean this is the tail wagging the dog. I would ask Member Goodson to have her Legislative Committee look at identifying who is on, who are these political appointments? I think she mentioned there are four. When their terms expire; the authority of the Governor to remove them before their terms expire and see about getting some more responsive and just more responsive appointments to that Board. They are obviously, out of step and abusing their power.

Member Goodson stated unless anyone has any other questions, that concludes my report.

We are keeping our plan off the shelf, keeping it moving forward and that is the end of my report.

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, (820 ILCS 130/0.01 et seq.), and

WHEREAS, the aforesaid Act requires that the County Board of Will County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of Will County employed in performing construction of public works for said County.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD OF WILL COUNTY:

<u>SECTION 1:</u> To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics

and other workers engaged in construction of public works coming under the jurisdiction of the County of Will is hereby ascertained to be the same as the prevailing wages for construction work in the Will County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the County of Will. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

<u>SECTION 2:</u> Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the County of Will to the extent required by the aforesaid Act.

<u>SECTION 3:</u> The Will County Clerk shall publicly post or keep available for inspection by an interested party in the main office of the County of Will this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

<u>SECTION 4:</u> The Will County Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

<u>SECTION 5:</u> The Will County Clerk shall promptly file a certified copy of this Ordinance with <u>both</u> the Secretary of State Index Division and the Department of Labor of the State of Illinois.

<u>SECTION 6:</u> The Will County Clerk shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.

BE IT FURTHER ORDAINED, that the Preamble of this Ordinance is hereby adopted as if fully set forth herein. This Ordinance shall be in full force and effect upon its passage and approval as provided by law.

There is created a political subdivision, body politic, and municipal corporation by the name of the Joliet Regional Port District embracing all the territory included within the present limits of the following townships in Will County, Illinois, now adjoining or traversed by the Illinois Waterway: DuPage, Lockport, Joliet, Troy and Channahon. Territory may be annexed to the District in the manner hereinafter provided in this Act. (Source: Laws 1957, p. 1302.)

(70 ILCS 1825/3.1) (from Ch. 19, par. 253.1)

Sec. 3.1. It is declared that the main purpose of this Act is to promote industrial, commercial and transportation activities, thereby reducing the evils attendant upon unemployment and enhancing the public health and welfare of this State.

All property of every kind belonging to the Port District shall be exempt from taxation, provided that taxes may be assessed and levied upon a lessee of the District by reason of the value of the real estate and all improvements thereon. All property of the District shall be construed as constituting public property owned by a municipal corporation and used exclusively for public purposes within the provisions of Section 15-155 of the Property Tax Code. (Source: P.A. 88-670, eff. 12-2-94.)

### Board information: (70 ILCS 1825/14) (from Ch. 19, par. 264)

Sec. 14. Board; compensation. The governing and administrative body of the Port District shall be a Board consisting of 10 members, to be known as the Joliet Regional Port District Board. All members of the Board shall be residents of Will County. The members of the Board shall serve without compensation but shall be reimbursed for actual expenses incurred by them in the performance of their duties. However, any member of the Board who is appointed to the office of secretary or treasurer may receive compensation for his or her services as such officer. No member of the Board or employee of the District shall have any private financial interest, profit or benefit in any contract, work or business of the District nor in the sale or lease of any property to or from the District. (Source: P.A. 96-1283, eff. 7-26-10.)

### (70 ILCS 1825/15) (from Ch. 19, par. 265)

Sec. 15. Appointment of Board. Within 60 days after this Act becomes effective the Governor, by and with the advice and consent of the Senate shall appoint 3 members of the Board who reside within the District outside the corporate boundaries of the City of Joliet for initial terms expiring June 1st of the years 1959, 1961, and 1963, respectively, and the Mayor, with the advice and consent of the City Council of the City of Joliet, shall appoint 3 members of the Board who reside within the City of Joliet for initial terms expiring June 1st of the years 1958, 1960, and 1962, respectively. Of the 3 members each appointed by the Governor and the Mayor not more than 2 shall be affiliated with the same political party at the time of appointment. Beginning with the first appointment made by the Governor, with the advice and consent of the Senate, after the effective date of this amendatory Act of the 96th General Assembly, the Governor must appoint members who reside within the District outside the corporate boundaries of the City of Joliet and the Village of Romeoville. Within 60 days after the effective date of this amendatory Act of the 94th General Assembly, the County Executive of Will County, with the advice and consent of the County Board, shall appoint 3 members of the Board for terms expiring June 1st of 2008, 2010, and 2012, respectively. Within 60 days after the effective date of this amendatory Act of the 96th General Assembly, the President of the Village of Romeoville, with the advice and consent of the corporate authorities of the Village of Romeoville, shall appoint one member of the Board who resides within the Village of Romeoville for an initial term expiring June 1st of 2016.

At the expiration of the term of any member, his or her successor shall be appointed by the Governor, Mayor, President of the Village of Romeoville, or County Executive of Will County in like manner and with like regard to political party affiliation and place of residence of the appointee, as appointments for the initial terms.

All successors shall hold office for the term of 6 years from the first day of June of the year in which the term of office commences, except in the case of an appointment to fill a vacancy. In case of vacancy in the office of any member appointed by the Governor during the recess of the Senate, the Governor shall make a temporary appointment until the next meeting of the Senate when he or she shall nominate some person to fill such office; and any person so nominated, who is confirmed by the Senate, shall hold his or her office during the remainder of the term and until his or her successor shall be appointed and qualified. If the Senate is not in session at the time this Act takes effect, the Governor shall make temporary appointments as in case of vacancies. The Governor, the Mayor, the President of the Village of Romeoville, and the County Executive shall certify their respective appointments to the Secretary of State. Within 30 days after certification of his or her appointment, and before entering upon the duties of his or her office, each member of the Board shall take and subscribe the constitutional oath of office and file it in the office of the Secretary of State.
