WHEREAS, the *Illinois Poison Center's* 24-hour toll-free hotline cares for nearly 82,000 poison-related cases throughout Illinois annually, with nearly 49 percent of those cases involving children ages five and under; and

WHEREAS, the IPC answers thousands of calls from hospital professionals and concerned family members every year, trains hundreds of toxicology experts, and creates educational material on poison prevention and treatment; and

WHEREAS, the IPC received 3,141 calls from Will County and prevented an estimated 823 ambulance runs and 1,376 Emergency Room visits; and

WHEREAS, 53,000 calls are triaged by the IPC annually, preventing Illinois residents from calling 9-1-1 first; and

WHEREAS, Illinois was the first state to get a poison control center approximately 60 years ago; and

WHEREAS, since 2009, the annual public funding of the *Illinois Poison Center* has decreased by approximately \$1.9 million, and without a stable funding mechanism the IPC is facing an impending closure date of June 30, 2014 so that Illinois will become the only state without a poison center; and

WHEREAS, there is pending in the 98th General Assembly Senate Bill 2674, that reallocates wireless surcharge funds being received by the ICC to provide a stable funding mechanism for *human poison control centers*, and necessary revenue for E911 Call Centers.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby supports the passage of SB2674 or like legislation to provide a stable funding mechanism for the Illinois Poison Center (a human poison control center), and necessary revenue for E911 Call Centers.
