PUBLIC COMMENT

Executive Walsh stated we do have one individual who has signed in, Ms. Wendy DeBellis, and she would like to speak on Resolution #14-105.

Ms. Wendy DeBellis stated her name and address. Thank you for allowing me to speak today. I saw your Agenda so I'm going to try and read this really quickly. In 1986, my husband and I bought our first home in Will County. We lived there for 12 years. Our children went to school in District 92 and I was very involved in the district for most of those 12 years that we lived there. I served on the school board and I worked hard to pass the referendum to reopen Reed School. In 1998, we moved to Wilton Center in unincorporated Will County and built our current home there on 10 acres. I went back to school, attending Joliet Junior College and I continued on and received my bachelors degree. While I attended college, I tutored adult students through Joliet's Reading Achievement Program through JJC. After I finished, I worked to help pay my children's college bills. My one daughter taught Spanish at Joliet High School and I have one that is currently a social worker at Laraway School in Joliet. More recently, I volunteered at the Joliet Animal Control and with local rescues as a foster home for dogs. My point is that I have been a Will County homeowner and resident for 28 years. I have volunteered to help the people of the community and the animals. I am currently trying to do something good. We still live

on our 10 acres in Wilton Center, and after volunteering at PAWS animal shelter and Joliet Animal Control and fostering animals for several local rescues, I learned more about the number of dogs and cats that are euthanized because community shelters and animal control facilities run out of space to house the homeless animals. There's been great improvements over the past years but as of now 80,000 dogs and cats are euthanized. That's four million a year at shelters. Because we have 10 acres, and the ability to do something, my husband and I went to Utah's Best Friends Animal Society and we attended a 7 day workshop on how to run an animal rescue; and then we committed to pursue this. Our children are now grown and married and we have the land and I can commit the time and energy to this with my husband, along with some friends and volunteers who have offered to help. We wanted to build a facility on our property and we contacted all of our neighbors. I thought we had 6 abutting neighbors and I talked to 5 of them. One of them had their phone disconnected. They all said they were okay with us starting the rescue. One wanted to be a volunteer, and another said that her daughter would love to help. No one said that they had a problem with us starting this rescue. When filing out the paperwork, I learned that the very back of my property abutted yet another neighbor on the road. I contacted her and she said she was excited about it and said she would also volunteer to help. Everything was going very well and I thank the Land Use department for all of their help, especially Dawn Tomczak who kept me informed on what I needed to get done in the deadlines that were required for filling out the paperwork, and how to make sure that it was done correctly. To summarize, we were scheduled to appear before the zoning committee on March 4th and the weekend before the meeting, I discovered that one of the neighbors had changed her mind and had started contacting other neighbors. She told them of a pit bull that attacked someone and was concerned about dogs barking. I called her and offered to have her come over and show her our plans. We had already started working with an architect and that we were working to make sure the noise would be contained and that our property would contain the dogs and everybody would be safe. I even told her that I would agree not to take pit bulls if that was one of her concerns. The day of the meeting, that neighbor and a couple others did show up. I later learned that they also contacted at least 3 other neighbors that refused to come. I know that we could stay where we are and continue to pursue the rescue here, but another house on a nearby 10 acres came up for sale and it is surrounded by farmlands. On the entire mile stretch of the road, there are only two homes across the street and none on the same side as that street. So. I contacted both of the homeowners that are across the street: one of them abuts the property. One of the couples said that they love animals and that they have a dog that they adopted through a rescue and they are okay with us having a rescue there. A couple live in the other home, which is across the street, she's a vet and she is involved in a dog club. She not only offered to help with vaccinations and if a dog became sick, she is also writing a grant to get a medical van so that their club can assist the Red Cross in disaster situations and they might need a place where they would put dogs if a disaster should occur where they would need to keep dogs, and that I would then be able to help them in any emergency situations. The farmland around that particular home that is for sale is owned by a woman who previously owned a home and I contacted her, I spoke with her, and she said she had no problem as well. There is vacant land across the street that I tried to contact the owner that is listed as, the property owner who is listed but each time I called the number I received a busy signal, so I was not able to get in touch with that person. My husband and I put an offer in on that home, and we will attempt to run the rescue there. We are scheduled to close on that home on June 2nd and we will have two mortgages until

we sell our home. So, please know that I am just asking if I can get a refund of fees so that in the future I could reapply those. I am not able to reapply those fees to this new property, so I'm asking for a refund so that in the future when we do move into this home and start the shelter there I can then apply the fees and that situation.

Executive Walsh stated are there any questions? I'm seeing none. Thank you, thank you very much.

ORDINANCE OF THE COUNTY BOARD WILL COUNTY, ILLINOIS

ADOPTING AND AMENDING CERTAIN PROVISIONS OF THE WILL COUNTY BUILDING ORDINANCE AND CODES

WHEREAS, Will County has the power by law, under Illinois Compiled Statutes, Chapter 55, Article 5, Sections 5/5-1063 and 5/5-1064, (55 ILCS 5/5-1063, 5/5-1064), to adopt or revise a building ordinance; and

WHEREAS, the Will County Board had adopted the International Building Code 2006, International Residential Code 2006, International Fire Code 2006, International Mechanical Code 2006, International Fuel Gas Code 2006, Illinois Energy Conservation Code 2012, International Electric Code 2005, the Illinois State Plumbing Code 2004, the Illinois Accessibility Code 1997; and

WHEREAS, in order to provide for the health, safety and welfare of residents, these codes should be reviewed and updated; and

WHEREAS, the Land Use and Development Committee of the Will County Board conducted a public hearing to consider, for use in the County of Will, the proposed Will County Building Ordinance, International Building Code 2012, International Residential Code 2012, International Fire Code 2012, International Mechanical Code 2012, International Fuel Gas Code 2006, Illinois Energy Conservation Code 2012, International Property and Maintenance Code 2012, National Electric Code 2011, the Illinois State Plumbing Code 2004, the Illinois Accessibility Code 1997 be adopted in their entirety; and

WHEREAS, the Land Use and Development Committee recommends the adoption of the proposed Will County Building Ordinance; and

WHEREAS, certain provisions of the current ordinance require revisions; and

WHEREAS, draft regulations were prepared by the staff to incorporate changes to Sections 10 through 22 and Articles 100 through 700; and

WHEREAS, the Land Use and Development Committee of the Will County Board held a public hearing, with proper public notice, on the proposed amendments to the Building Ordinance and reviewed and recommended to the County Board that said amendments be adopted.

NOW, THEREFORE, BE IT ORDAINED, by the Will County Board that the attached Will County Building Ordinance (as amended in accordance with the provisions attached hereto and made a part hereof) and the proposed Will County Building Ordinance, International Building Code 2012, International Residential Code 2012, International Fire Code 2012, International Mechanical Code 2012, International Fuel Gas Code 2012, Illinois Energy Conservation Code 2012, International Property and Maintenance Code 2012, National Electric Code 2011, the Illinois State Plumbing Code 2004, the Illinois Accessibility Code 1997 be adopted in their entirety.

BE IT FURTHER ORDAINED, that the Will County Clerk is directed to forward a copy of this Ordinance to American Legal Publishing to be incorporated into the Will County Code of Ordinances.

BE IT FURTHER ORDAINED; BY THE WILL COUNTY BOARD THAT:

- 1. This Ordinance, and every provision thereof, shall be considered separable, and the invalidity of any portion shall not affect the validity of the remainder.
- 2. All Ordinances and Resolution, or parts thereof, in conflict herewith are hereby repealed.
- 3. This Ordinance and Codes shall be effective June 1, 2014.

DESIGNATING THE GOODING ISSERT FARMSTEAD AS A HISTORIC LANDMARK

WHEREAS, the County of Will has enacted the Will County Historic Preservation Ordinance, adopted September 17, 1992, and providing for the creation of the Will County Historic Preservation Commission, and

WHEREAS, there exists a farmstead that is deemed significant located at 21204 West Ballou, Wilmington, Illinois 60481, P.I.N: 25-06-400-012-0000, and

WHEREAS, the Will County Historic Preservation Commission has the authority to recommend to the Will County Board that the subject farmstead be included on the Will County Register of Historic Places, and

WHEREAS, the Will County Historic Preservation Commission further has the authority pursuant to the Will County Historic Preservation Ordinance, Article IV, to recommend to the Will County Board, properties and structures suitable to be designated as historic landmarks, and

WHEREAS, the farmstead is historically known as the Gooding Issert Farmstead and commonly known as the Gooding Issert Farmstead, and

WHEREAS, a public hearing was duly held on April 2, 2014, and

WHEREAS, on April 2, 2014, the Will County Historic Preservation Commission voted to recommend landmark designation to the Will County Board for the subject structure, and

WHEREAS, the Land Use and Development Committee recommended approval of this request.

NOW, THEREFORE, BE IT RESOLVED, BY THE WILL COUNTY BOARD AS FOLLOWS:

- 1. That this farmstead, commonly known as the Gooding Issert Farmstead meets the requisite number of criteria necessary for designation as a landmark under the Will County Historic Preservation Ordinance.
- 2. That this farmstead, historically known as the Gooding Issert Farmstead be recognized as a Will County Historic Landmark.
- 3. This Resolution shall take effect, following its passage, approval, recording, inspection and publication, as may be required by law.

Refund Request of Zoning Fees (Case 6157-SV, Mike and Wendy DeBellis)

WHEREAS, the Will County Board has established a Land Use Department Fee Schedule for the application of map amendments, special use permits and variances from the Zoning Ordinance; and

WHEREAS, Mike and Wendy DeBellis were the applicants for Will County Zoning Case 6157-SV, which was heard by Planning and Zoning Commission on March 4, 2014 and requested to continue this case at Land Use Development Committee on March 11, 2014; and

WHEREAS, the applicants on April 4, 2014, withdrew their zoning request for a special use permit to operate a rescue for homeless dogs and variance to allow separation distance for housing of animals, and stated a financial hardship; and

All property of every kind belonging to the Port District shall be exempt from taxation, provided that taxes may be assessed and levied upon a lessee of the District by reason of the value of the real estate and all improvements thereon. All property of the District shall be construed as constituting public property owned by a

municipal corporation and used exclusively for public purposes within the provisions of Section 15-155 of the Property Tax Code. (Source: P.A. 88-670, eff. 12-2-94.)

Sec. 14. Board; compensation. The governing and administrative body of the Port District shall be a Board consisting of 10 members, to be known as the Joliet Regional Port District Board. All members of the Board shall be residents of Will County.

However, any member of the Board who is appointed to the office of secretary or treasurer may receive compensation for his or her services as such officer. Within 60 days after this Act becomes effective the Governor, by and with the advice and consent of the Senate shall appoint 3 members of the Board who reside within the District outside the corporate boundaries of the City of Joliet for initial terms expiring June 1st of the years 1959, 1961, and 1963, respectively, and the Mayor, with the advice and consent of the City Council of the City of Joliet, shall appoint 3 members of the Board who reside within the City of Joliet for initial terms expiring June 1st of the years 1958, 1960, and 1962, respectively. Of the 3 members each appointed by the Governor and the Mayor not more than 2 shall be affiliated with the same political party at the time of appointment. Beginning with the first appointment made by the Governor, with the advice and consent of the Senate, after the effective date of this amendatory Act of the 96th General Assembly, the Governor must appoint members who reside within the District outside the corporate boundaries of the City of Joliet and the Village of Romeoville. Within 60 days after the effective date of this amendatory Act of the 94th General Assembly, the County Executive of Will County, with the advice and consent of the County Board, shall appoint 3 members of the Board for terms expiring June 1st of 2008, 2010, and 2012, respectively. Within 60 days after the effective date of this amendatory Act of the 96th General Assembly, the President of the Village of Romeoville, with the advice and consent of the corporate authorities of the Village of Romeoville, shall appoint one member of the Board who resides within the Village of Romeoville for an initial term expiring June 1st of 2016.

At the expiration of the term of any member, his or her successor shall be appointed by the Governor, Mayor, President of the Village of Romeoville, or County Executive of Will County in like manner and with like regard to political party affiliation and place of residence of the appointee, as appointments for the initial terms.

All successors shall hold office for the *term of 6 years* from the first day of June of the year in which the term of office commences, except in the case of an appointment to fill a vacancy. In case of vacancy in the office of any member appointed by the Governor during the recess of the Senate, the Governor shall make a temporary appointment until the next meeting of the Senate when he or she shall nominate some person to fill such office; and any person so nominated, who is confirmed by the Senate, shall hold his or her office during the remainder of the term and until his or her successor shall be appointed and qualified. If the Senate is not in session at the time this Act takes effect, the Governor shall make temporary appointments as in case of vacancies. The Governor, the Mayor, the President of the Village of Romeoville, and the County Executive shall certify their respective appointments to the Secretary of State. Within 30 days after certification of his or her appointment, and before

entering upon the duties of his or her office, each member of the Board shall take and subscribe the constitutional oath of office and file it in the office of the Secretary of State.
