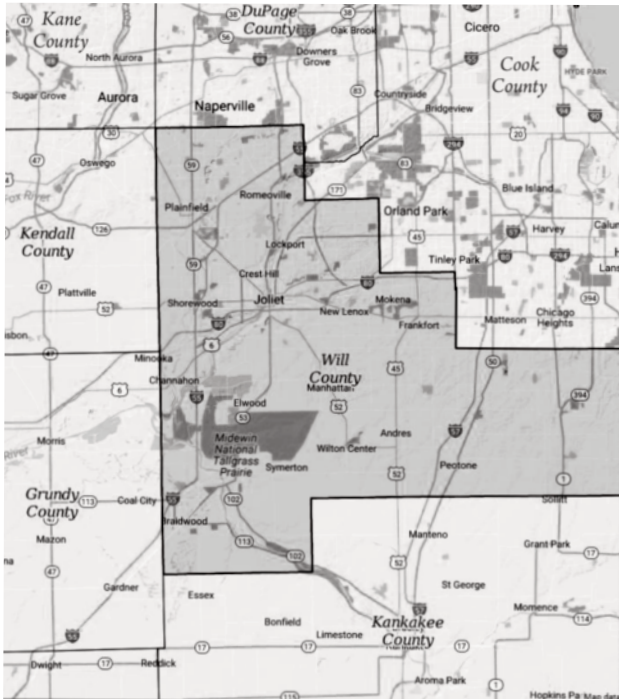

FREQUENTLY ASKED QUESTIONS**1**

WHAT IS A PRECINCT?

Each of the 24 townships in Will County are subdivided into smaller geographical boundaries where all addresses within this boundary vote at a specific location.

WHAT IS A PARTIAL PRECINCT?

The district makeup within each precinct may vary. Not all addresses may be within the same municipal, park, library, school or fire district.

WHAT IS A TAXING DISTRICT?

There are over 200 taxing districts within Will County. Each specific voting address is only eligible to vote for candidates or referenda for those specific taxing districts which appear on their property tax bill.

WHAT ARE TAX CODES?

Each piece of property in Will County is assigned a specific tax code, which is a combination of the various taxing districts the property falls within.

WHY DIFFERENT BALLOT STYLES?

Since most precincts do not sit entirely within the same Congressional, Legislative, State Representative, County Board, municipal, park, library, school or fire district, these different combinations are what make up a Ballot Style. That is why it is so important for the voter to make sure they are given the correct Ballot Style on Election Day.

WHAT IS THE VOTER INFORMATION GUIDE FOR?

Due to the limited circulation of newspapers, the County Clerk's Office now sends out a Voter Information Guide to each household with registered voters. It provides their options for voting as well as a Sample Ballot. This information was previously published in local newspapers but could not be tailored to the individual voter as it is now.

WHAT ARE MY VOTING OPTIONS?

Vote by Mail

Vote in the privacy of your home. Registered voters can call the County Clerk's Office and request a ballot be mailed to them at least three months prior to each election. Vote by Mail ballots must be postmarked by Election Day in order for the ballot to be counted.

Early Voting

If you don't want to wait until Election Day to cast your ballot, you can vote early. No ID is required as long as your signature matches your facsimile signature from the Voter Registration database. Early Voting ballots are cast by personal appearance at the County Clerk's Office or at your designated Early Voting site.

Grace Period Registration & Voting

Any voter who was unable to update their voting address or register for the first time for any upcoming election, is eligible for Grace Period voting. After the close of registration and through Election Day, Grace Period voting will be available only at the County Clerk's Office. The voter must provide two forms of ID (one of which must show current address) and be prepared to vote at the same time.

Polling Place

Polls are open from 6:00 am – 7:00 pm on Election Day. Registered voters are notified of their current polling place on their Voter Identification card as well as their Voter Information Guide which is sent to their residence prior to every election.

Same Day Registration

Same Day Registration is also available at all polling places in Will County on Election Day. However, you must go to your designated polling place for your residence. Voter must provide two forms of ID (one of which must show current address) in order to register to vote that day.

WHAT VOTER INFORMATION IS AVAILABLE?

The County Clerk's Office can provide voter history lists, address labels or the information in a digital format to candidates, proponents and opponents of a referenda and political subdivisions. This data can only be used for bonafide political purposes and shall not be used under any circumstance for purposes of commercial solicitation or other business purposes, and that to do so may result in substantial penalty.

HOW CAN I REGISTER TO VOTE?

U.S. citizens by birth or naturalization can register to vote either online, by mail, in person at the County Clerk's Office, DMV, with a Deputy Registrar or at your polling place on Election Day. (Two forms of ID are required, one of which must show current address)

WHAT IS A LOCAL ELECTION OFFICIAL?

The clerk or secretary of a unit of local government who is assigned election duties such as handing out petitions, filing petitions, providing certificates of ballots, etc.

WHAT IS A JURISDICTION?

An entire county, in the case of a county in which no city board of election commissioners is located or which is under the jurisdiction of a county board of election commissioners, the territorial jurisdiction of a city board of election commissioners, and the territory in a county outside of the jurisdiction of a city board of election commissioners. In each instance election jurisdiction shall be determined according to the location of the political subdivision's principal office.

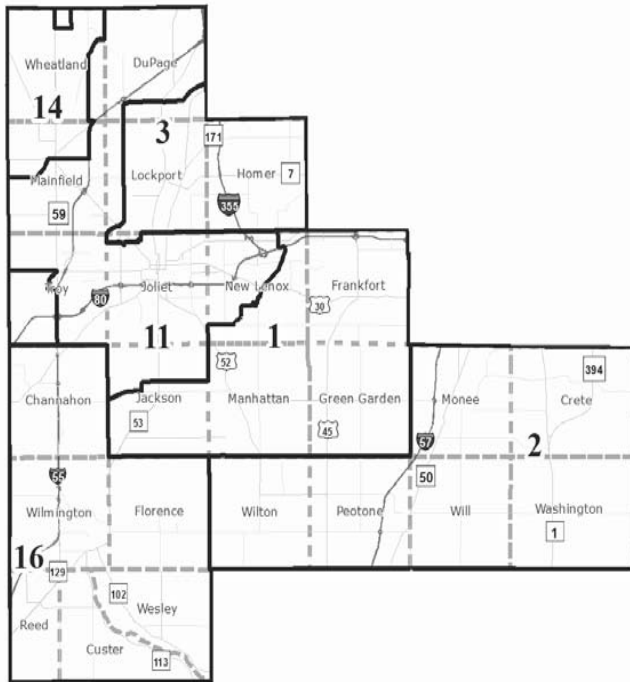

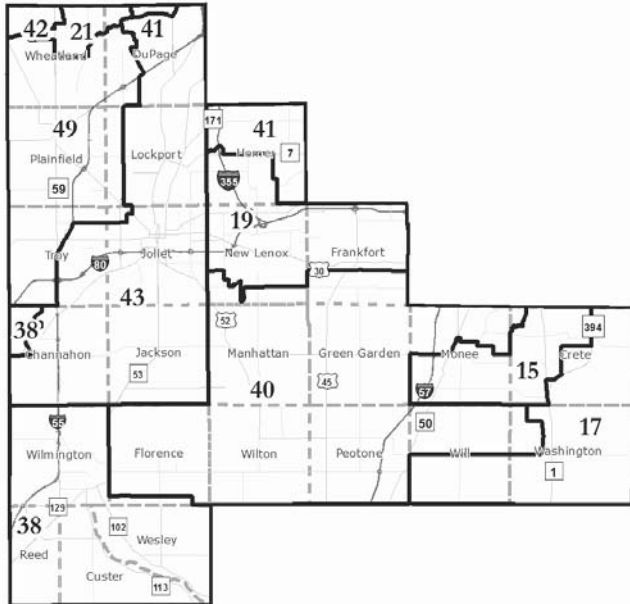

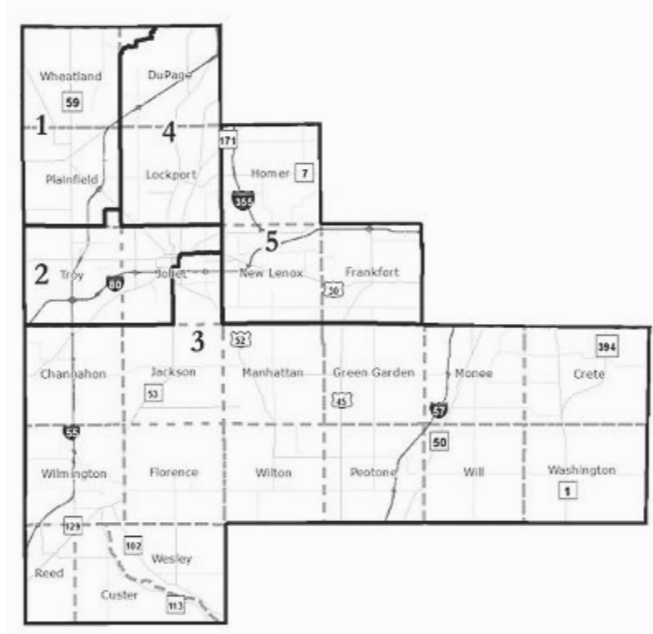
