VERIFIED OBJECTOR'S PETITION

Now comes Paul Powell, hereinafter referred to as Objector, and states as follows:

1. Objector resides at 24820 W. Prairie Grove Drive, Plainfield, IL 60585, in Will County, and is duly qualified, registered and legal voter at such address, and his interest in filing the following objection is that of a citizen desirous of seeing that the laws governing the filing of Nomination Papers for a candidate for election to the Office of Will County Chief Executive Officer are properly complied with and that only qualified candidates have their names appear upon the ballot as candidates for that office.

2. Your Objector makes the following objection to the nomination papers of Michael Messina as a Republican candidate for the Office of Will County Chief Executive Officer and states that said Nomination Papers are insufficient in law and in fact for the following reasons:

3. Pursuant to the Illinois Election Code, "If a candidate seeks to run for any countywide office, ... the candidate's petition for nomination must contain at least the number of signatures equal to 0.5% of the qualified electors of his or her party who cast votes at the last preceding general election in his or her county." ((10 ILCS 5/7-10(c) & (10 ILCS 5/7-3).

4. That in the last preceding general election in Will County that occurred on November 6, 2018, the certified canvas results showed that there were 119,249 qualified electors of the Republican party who cast votes.

5. That 0.5% of 119,249 is 597.

6. Pursuant to state law, nomination papers and petitions for Will County Chief Executive Officer, Will County Illinois, to be voted upon in the Republican Primary of the General Primary Election to be held on March 17, 2020, must contain not fewer than 597 valid signatures of duly qualified, registered and legal voters of Will County collected in a manner prescribed by law.

7. That the nominating petition of Michael Messina for the Republican Nomination for Will County Chief Executive Officer filed on December 2, 2019 purports to contain 481 signatures spread amongst 49 pages, which is 116 votes (or, nearly 20%) short of the minimum number of valid signatures of registered voters required by the Illinois Election Code. (A copy of the Nominating Petition of Michael Messina is attached.)

8. Objector further states that "the minimum signature requirement imposed by section 10-3 of the Election Code is mandatory and must be followed."

Jackson-Hicks v. East St. Louis Board of Election Commissioners, 2015 IL 118929, ¶ 42. "[T]he clear and unambiguous standard adopted by the General Assembly requires compliance with a specific numerical threshold determined according to a specific mathematical formula. A candidate either meets that minimum threshold or does not. There is no close enough." *Jackson-Hicks*, 2015 IL 118929, ¶ 37

WHEREFORE, the Objector prays that the purported Nomination Papers of Michael Messina for the nomination of the Republican Party for Will County Chief Executive Officer be declared insufficient and not in compliance with the laws of the State of Illinois and a ruling that the name Michael Messina as a Republican Candidate for the Office of Will County Chief Executive Officer shall not appear and not be printed on the ballot to be voted for at the General Primary Election to be held on March 17, 2020.
