

**AN ORDER CALLING A BOND ELECTION TO BE HELD NOVEMBER 7, 2023, WITHIN LUBBOCK COUNTY, TEXAS, MAKING PROVISION FOR THE CONDUCT AND GIVING NOTICE OF SAID ELECTION, AND CONTAINING OTHER PROVISIONS NECESSARY AND INCIDENTAL TO THE PURPOSES HEREOF**

WHEREAS, the Commissioners Court of Lubbock County, Texas, hereby finds that an election should be held to determine whether said governing body shall be authorized to issue bonds of said County in the amount and for the purposes hereinafter identified; and

WHEREAS, the Commissioners Court of Lubbock County, Texas (the "County") has heretofore found that the funding and construction, of certain improvements within the County is in the public interest; and

WHEREAS, the Commissioners Court is authorized pursuant to Chapters 42 and 85 of the Texas Election Code to designate dates, times, and locations for election day voting and early voting by personal appearance; and

WHEREAS, the Commissioners Court hereby finds that it is in the public interest that the County special bond election be conducted as provided for by the Commissioners Court;

THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF LUBBOCK COUNTY, TEXAS:

**Section 1. Call of Election; Date; Eligible Electors; and Hours.** A special bond election (the "Election") shall be held on Tuesday, November 7, 2023, which is seventy-eight (78) or more days from the date of the adoption of this order (the "Order") within and throughout the County, at which all resident, qualified electors of the County shall be entitled to vote, and is not less than fifteen (15) or more than ninety (90) days from the date of the adoption hereof. The Commissioners Court hereby finds that holding the Election on such date is in the public interest.

**Section 2. Conduct of Election.** The Election shall be conducted by the Lubbock County Elections Administrator, in accordance with the Texas Election Code, Chapter 1251 of the Texas Government Code, and the Constitution and laws of the State of Texas and the United States of America. The early voting and election day voting locations shall be located within Lubbock County and serve the County's registered voters. The County's currently existing election precincts shall be the precincts for the Election unless vote centers established by the County are used. All voting locations to be used for the Election are attached as **Exhibit A** and incorporated herein by reference. The Hart Verity Touch voting system with Canon DR-G2140 scanners shall be utilized for the Election.

The Commissioners Court approves the appointment of persons designated by the County Elections Administrator to serve as election workers. Such proposed presiding judges and alternate judges shall meet the eligibility requirements of Chapter 32, Subchapter C of the Texas Election Code. The rate of pay for judges and clerks of the Election, including compensable hours

shall be determined in accordance with the provisions of the Texas Election Code, as amended and other applicable laws. The Commissioners Court approves the appointment of persons designated by the County Elections Administrator to serve on the Early Voting Ballot Board, at the Central Counting Station, and as deputy early voting clerks. A public school of instruction for all election judges and clerks will be held. All notices, instructions, and ballots pertaining to the Election shall be furnished to voters in both English and Spanish and persons capable of acting as translators in both English and Spanish shall be made available to assist Spanish language speaking voters in understanding and participating in the election process.

**Section 3.**     **Proposition.**     At the Election there shall be submitted to the resident, qualified electors of the County the following proposition (the “Proposition”):

Lubbock County Proposition A

“SHALL the Commissioners Court of Lubbock County, Texas, be authorized to issue general obligation bonds of said County in the aggregate principal amount of \$35,485,000 to provide funds for designing, planning, constructing, improving, maintaining, upgrading, and equipping a new facility that will serve as the Lubbock County Medical Examiner’s Office; such bonds of each series or issue, respectively, to mature serially or otherwise over a period not to exceed thirty (30) years from their date, and to be issued in such installments and sold at such price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise and not exceed the maximum rate prescribed by law) as shall be determined within the discretion of the Commissioners Court under laws in effect at the time of issuance; and to provide for the payment of the principal of and interest on said bonds by levying and collecting annual ad valorem taxes upon all taxable property within the County in an amount sufficient to pay the annual interest on said bonds and to provide a sinking fund sufficient to pay said bonds as they become due?”

**Section 4.**     **Ballots.**     The ballot shall be suitable for use with an electronic voting system, and for voting by mail and shall otherwise conform to the requirements of the Texas Election Code as to permit electors to vote “FOR” or “AGAINST” the aforesaid measure which shall appear on the ballot substantially as follows:

**Section 5. Debt Service and Tax Rate Information of the County.** The following information is provided in accordance with the provisions of Section 3.009(b), Texas Election Code.

- (a) The Proposition language that will appear on the ballot is set forth in Section 4 hereof.
- (b) The purpose for which the bonds are to be authorized is set forth in Sections 3 and 4 hereof.
- (c) The principal amount of the debt obligations to be authorized is \$35,485,000.
- (d) Taxes sufficient to pay the annual principal of and interest on the general obligation bonds may be imposed.
- (e) If the bonds are approved, they may be issued in one or more series, to mature serially, over a period not to exceed thirty (30) years from the date of issuance of each series of bonds.
- (f) The County's outstanding aggregate principal amount of debt as of the date of this Order is \$85,250,000.
- (g) The aggregate amount of the interest owed on such County debt obligations, through respective maturity as of the date of this Order is \$29,278,340.09.
- (h) The County has levied an ad valorem debt service tax rate for its outstanding debt obligations of \$0.033298 per \$100 of taxable assessed valuation.
- (i) The weighted average maturity of the issue of bonds does not exceed 120% of the reasonably expected weighted average economic life of the improvements and personal property financed with the issue of bonds.
- (j) The County will issue the bonds authorized by the Proposition in accordance with a schedule to be determined by the Commissioners Court based upon several factors, including, but not limited to, the then current needs of the County, demographic changes, prevailing market conditions, assessed valuations in the County and management of the County's short-term and long-term interest rate exposure. Market conditions, demographics, and assessed valuations vary based upon several factors beyond the County's control, and therefore, the County cannot and does not guarantee a particular interest rate or tax rate associated with the bonds authorized by the Proposition. As such, the information contained in this paragraph is provided solely for illustrative purposes and does not establish any limitations or restrictions or create a contract with the voters. The County currently estimates that, if the Proposition were approved and the bonds proposed herein were authorized and issued in accordance with the County's current estimated project plan of finance, the maximum interest rate of the bonds is not expected to exceed 15%. Such estimate takes into account a number of factors, including the issuance schedule, maturity schedule and the expected bond ratings of the proposed bonds.

If a majority of the resident, qualified electors of the County voting at the Election, including those voting early, shall vote in favor of the Proposition, then the issuance and sale of

the bonds shall be authorized in the maximum amount contained therein, and the general obligation bonds shall be issued and sold at the price or prices and in such denominations determined by the Commissioners Court to be in the County's best interests. County staff shall prepare a voter information document and post such documents in accordance with Section 1251.052 of the Texas Government Code.

**Section 6. Early Voting.** Early voting for the Election shall be conducted jointly with other political subdivisions, if any. The Lubbock County Elections Administrator shall serve as the Early Voting Clerk, and shall appoint any necessary deputy early voting clerks to assist.

An original, signed application for a ballot by mail may also be submitted via email. The original application must be mailed to the Early Voting Clerk and must be received within four (4) days of the submission. For the use of those voters who are entitled by law to vote early by mail, the Early Voting Clerk shall provide each voter with a ballot with instructions to mark the ballot indicating his or her vote "FOR" or "AGAINST" the Proposition on the same ballots utilized for early voting by personal appearance at the Election. The period to apply for a ballot by mail is January 1, 2023, through October 27, 2023. The application must be received by the Early Voting Clerk by October 27, 2023, (mere postmarking by the deadline is insufficient).

#### Early Voting by Personal Appearance

Early voting by personal appearance will be conducted October 23, 2023, through November 3, 2023. The hours and address for the main early voting location are designated in **Exhibit A** to this Order. Additionally, permanent and/or temporary branch early voting locations will be established and maintained in accordance with the Texas Election Code. Information regarding the locations, dates and hours of operation for early voting at these locations shall be determined by the County Elections Administrator, as identified in **Exhibit A** hereto. The County Judge and County Elections Administrator and their designees are hereby authorized to modify **Exhibit A** to include additional or different early voting locations and hours.

**Section 7. Delivery of Voted Ballots; Counting; Tabulation; Canvassing of Returns; Declaring Results.** In accordance with the requirements of the Election Code, the election officers, including election judges, central count personnel, and the County Elections Administrator shall make and deliver a written returns of the Election. The Commissioners Court shall canvass the returns and declare the results of the Election.

**Section 8. Custodian of Records.** The County Elections Administrator is the custodian of records (“Custodian”) and will perform duties related to the conduct and maintenance of records of the Election as required under the Texas Election Code during the period beginning the third (3rd) day after the adoption of this Order and ending not earlier than the fortieth (40th) day after the date of the Election. In particular, the Custodian shall accept and maintain records regarding campaign expenditures that may be filed with the County and any precinct election records. The Custodian shall maintain, in office, the documents, records and other items relating to the Election and shall be the person designated to receive documents on behalf of the County that are required by the Texas Election Code. The Custodian shall maintain an office open for election duties for at least three (3) hours each day, during regular office hours, on regular business days during the period designated in this section. The Custodian shall post notice of the location and hours of office as required by the Texas Election Code.

**Section 9. Notice of Election Publication and Posting Requirements.**

Notice of the Election, containing a substantial copy of this Order, shall be published on the same day in each of two successive weeks, in the English and Spanish languages, in a newspaper published within the County at least fourteen (14) days and no more than thirty (30) days before the Election and as otherwise may be required by the Texas Election Code. Moreover, Notice of the Election, containing a substantial copy of this Order, in both the English and Spanish languages, shall also be posted (i) on the notice board used by the Commissioners Court to post notices of meetings, (ii) at three (3) other public places within the County, and (iii) on the County’s website, prominently and together with the notice of the election, voter information document, sample ballot, and contents of the Proposition, no later than the twenty-first (21<sup>st</sup>) day before the Election. Additionally, the County Judge and County Elections Administrator, in consultation with bond counsel, are hereby authorized and directed to provide any other manner of notice as authorized by law. A copy of this Order, and the voter information document, in both the English and Spanish languages, shall be posted in a prominent location at each early voting location and at each voting location on Election Day.

**Section 10. Necessary Actions.** The County Judge and the County Election Administrator, in consultation with the County Attorney and bond counsel, shall have the authority to take, or cause to be taken, all actions reasonable and necessary to ensure that the Election is fairly held and returns properly counted and tabulated for canvass by the Commissioners Court, which actions are hereby ratified and confirmed. Without limiting the generality of the immediately preceding sentence, the County Judge and County Elections Administrator and their designees are hereby authorized to complete and update, as necessary, the exhibits attached hereto with voting locations and other information as same is made available by the County Elections Administrator.

**Section 11. Preamble Incorporation.** The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Order for all purposes and are adopted as a part of the judgment and findings of the Commissioners Court.

**Section 12. Inconsistent Provisions.** All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Order are hereby repealed to the extent of such conflict, and the provisions of this Order shall be and remain controlling as to the matters found herein.

**Section 13. Governing Law.** This Order shall be construed and enforced in accordance with the orders and resolutions of Lubbock County, Texas, and the laws of the State of Texas and the United States of America.

**Section 14. Severability.** If any provision of this Order or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Order and the supplication of such provision to other persons and circumstances shall nevertheless be valid, and the Commissioners Court hereby declares that this Order would have been enacted without such invalid provision.

**Section 15. Notice of Meeting.** The Commissioners Court officially finds, determines, recites and declares that written notice of the date, hour, place and subject of the meeting at which this Order is adopted was posted on a bulletin board located at a place convenient to the public at the County Courthouse for at least seventy-two (72) hours preceding the scheduled time of the meeting; and that a telephonic or telegraphic notice of such meeting was given to all news media who have consented to pay any and all expenses incurred by the County in connection with providing such notice, both as required by the Open Meetings Law, Chapter 551, Texas Government Code, as amended; and that such meeting was open to the public as required by law at all times during which this Order and the subject matter thereof was discussed, considered and formally acted upon.

**Section 16. Authorization to Execute.** The County Judge is authorized to execute and the County Clerk is authorized to attest this Order on behalf of the Commissioners Court; and the County Judge is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

**Section 17. Effective Date.** This Order is effective immediately upon its passage and approval.


