### VERIFIED OBJECTOR'S PETITION

#### Introduction

Melissa Boatman, Chairman of the Will County Young Republicans, hereinafter sometimes referred to as the "Objector", states as follows:

- 1. The Objector, Melissa Boatman, resides at <u>328 Stonegate Road, Bolingbrook, Illinois 60440</u>, and is a duly qualified, legal and registered voter at that address, having been a resident of the village of Bolingbrook for more than one year prior to the June 28, 2022, General Primary Election.
- 2. The Objector's interest in filing this Petition is that of a voter and resident desirous to ensure that the laws governing the filing of Nomination Papers for the Office of Will County Board Member of Will County, Illinois ("the Office") are properly complied with and that only qualified candidates who meet all statutory and legal requirements appear on the ballot for said office.

### **OBJECTIONS**

3. The above-named Objector makes the following objections to the purported nomination papers ("Nomination Papers") and the candidacy of Jacqueline Traynere ("Candidate"), a purported candidate for Will County Board Member, District 11, of Will County, Illinois, to be voted at the General Primary Election on June 28, 2022 ("the Election"). The Objector states that the Nomination Papers are insufficient in law and fact for the following reasons:

#### APPLICABLE LAW

- 4. The Illinois Election Code (10 ILCS 5/10-5) (from Ch. 4, par. 10-5) provides as follows:
  - 1. (10 ILCS 5/10-5) (from Ch. 46, par. 10-5)

Sec. 10-5. All petitions for nomination shall, besides containing the names of candidates, specify as to each:

- 1. The office or offices to which such candidate or candidates shall be nominated.
- 2. The new political party, if any, represented, expressed in not more than 5 words. However, such party shall not bear the same name as, nor include the name of any established political party as defined in this Article. This prohibition does not preclude any established political party from making nominations in those cases in which it is authorized to do so.
- 3. The place of residence of any such candidate or candidates with the street and number thereof, if any. In the case of electors for President and Vice-President of the United States, the names of candidates for President and Vice-President may be added to the party name or appellation.

Such certificate of nomination or nomination papers in addition shall include as a part thereof, the oath required by Section 7-10.1 of this Act and must include a statement of candidacy for each of the

candidates named therein, except candidates for electors for President and Vice-President of the United States. Each such statement shall set out the address of such candidate, the office for which he is a candidate, shall state that the candidate is qualified for the office specified and has filed (or will file before the close of the petition filing period) a statement of economic interests as required by the Illinois Governmental Ethics Act, shall request that the candidate's name be placed upon the official ballot and shall be subscribed and sworn to by such candidate before some officer authorized to take acknowledgments of deeds in this State, and may be in substantially the following form: State of Illinois)

### 2. (10 ILCS 5/10-4) (from Ch. 46, par. 10-4)

Sec. 10-4. Form of petition for nomination. All petitions for nomination under this Article 10 for candidates for public office in this State, shall in addition to other requirements provided by law, be as follows: Such petitions shall consist of sheets of uniform size and each sheet shall contain, above the space for signature, an appropriate heading, giving the information as to name of candidate or candidates in whose behalf such petition is signed; the office; the party; place of residence; and such other information or wording as required to make same valid, and the heading of each sheet shall be the same. Such petition shall be signed by the qualified voters in their own proper persons only, and opposite the signature of each signer his residence address shall be written or printed. The residence address required to be written or printed opposite each qualified primary elector's name shall include the street address or rural route number of the signer, as the case may be, as well as the signer's county, and city, village or town, and state. However, the county or city, village or town, and state of residence of such electors may be printed on the petition forms where all of the electors signing the petition reside in the same county or city, village or town, and state. Standard abbreviations may be used in writing the residence address, including street number, if any. Except as otherwise provided in this Code, no signature shall be valid or be counted in considering the validity or sufficiency of such petition unless the requirements of this Section are complied with. At the bottom of each sheet of such petition shall be added a circulator's statement, signed by a person 18 years of age or older who is a citizen of the United States; stating the street address or rural route number, as the case may be, as well as the county, city, village or town, and state.

5. Based on voter turnout and statue, the Will County Clerk's Office has determined and declared that a minimum of eighty-one (81) voters' signatures are necessary for a proper Petition for a candidate seeking nomination for the office of Will County Board Member. (See Exhibit A attached hereto.)

#### STATEMENT OF VIOLATIONS

- 6. The candidate submitted a petition numbering thirty-eight (38) pages and signed by three hundred twenty-two (322) individuals. (A copy of said Petition is attached hereto as Exhibit B.)
- 7. The Candidate's Petition is deficient in that it fails to contain the *signatures* of at least eighty-one (81) "voters" as required by statute.

- 8. The Candidate's Petition is invalid for the stated reason(s):

- 8. Petition page 10, line 10 unreadable.
- 9. Petition page 19, line 8 unreadable.
- 10. Petition page 20, line 5 unreadable.
- 11. Petition page 23, line 5 unreadable.
- 12. Petition page 26 circulator name unreadable.
- 13. Petition page 33, lines 5, 6, 8, 9, 10 unreadable.
- 14. The Code of Campaign Practices states that no candidate will undertake or condone any dishonest or unethical practice that tends to corrupt or undermine our American system of free elections or that hamper or prevents the full and free expression of the will of the voters. For example: circulating, accepting, or the filing of petition packets for declared candidates for elected office while holding elected office on the Will County Board. Such actions are a violation of the Boards Governance Rules and Procedures adopted on December 7th, 2020. (Section 1-1) Political activities including Initiating for circulation, preparing, circulation, reviewing or filing any petition on behalf of a candidate for elective office or for or against any referendum.

Every page of the Petition heading is not uniform. Statement of candidacy address is deficient in that it fails to make the distinction from city, village or unincorporated area of Bolingbrook. The circulator address is deficient on ten (10) pages (3, 5, 6, 19, 20, 21, 25, 28, 29, 38). The top of every page of signatures is deficient in the fact that the address fails to make the distinction from city, village or unincorporated area of Aurora. Duplicate signatures:

9. With striking the aforementioned invalid Petition, at most, the Candidate's Petition contains the signatures of only zero (0) "voters."

### **VIOLATIONS OF ILLINOIS ELECTION CODE**

- 10. The Illinois Election Code as specified above specifically mandates that all petitions for nomination shall, besides containing the names of candidates, specify as to each:

  The office or offices to which such candidate or candidates shall be nominated.

  Except as otherwise provided in this Code, no signature shall be valid or be counted in considering the validity or sufficiency of such petition unless the requirements of this Section are complied with. At the bottom of each sheet of such petition shall be added a circulator's statement, signed by a person 18 years of age or older who is a citizen of the United States; stating the street address or rural route number, as the case may be, as well as the county, city, village or town, and state.
- 11. As indicated above, a candidate for Will County Board Member must submit a Petition signed by at least eighty-one (81) voters.

- 12. The Candidate's Petition is invalid in the fact that the every page of the Petition heading is not uniform. Statement of candidacy address is deficient in that it fails to make the distinction from city, village or unincorporated area of Bolingbrook. The circulator address is deficient on ten (10) pages (3, 5, 6, 19, 20, 21, 25, 28, 29, 38). The top of every page of signatures is deficient in the fact that the address fails to make the distinction from city, village or unincorporated area of Aurora. Duplicate signatures:

- 13. By reason of the facts set forth above, the Candidate has not submitted a complete and valid Petition so as to be allowed on the ballot for the June 28, 2022, General Primary Election and is in violation of the provisions of Statute as cited above.

#### CONCLUSION

WHEREFORE, the Objector requests a hearing on the objections set forth herein, an examination by the aforesaid Electoral Board of the Official Records pertaining to the Candidate's Petition and relevant voters' records, to the extent that such examination is pertinent to any of the matter alleged herein, a ruling that the Nomination Papers are insufficient in law and fact, and a ruling striking the candidacy of Jacqueline Traynere, declaring the Nomination Papers of Jacqueline Traynere invalid, and ordering that the name of Jacqueline Traynere shall not appear and not be printed on the ballot for election to the Office of Will County Board Member, District 11, of Will County, Illinois, to be voted for at the General Primary Election to be held June 28, 2022.

## PETITION FOR NOMINATION
