VERIFIED OBJECTOR'S PETITION

NOW COMES, JOSEPH FERGUSON hereinafter referred to as the "Objector," by and through his attorney, ROBERT F. WISNIEWSKI, and makes the following objections to the Precinct Committeeperson Petition of GEORGENE JABACK as a candidate for election as a Democratic Precinct Committeeperson from Joliet 3 and states as follows:

1. That the Objector JOSEPH FERGUSON resides at 1206 Clement Street, Joliet, Illinois which is in Joliet Township Precinct 3 in Joliet, Will County, Illinois.
2. The Objector is a registered legal voter at such address.
3. That the Objector's interest in filing the following objections is that of a citizen desirous of seeing to it that the laws governing the filing of nomination papers for election to the office of Democratic Committeeperson for Joliet Township Precinct 3, Joliet, Will County, Illinois, are properly complied with and that only qualified candidates have their names appear on the ballot as candidates for said office.

4. Your objector states that in Precinct Joliet 3 the signatures of not less than 7 duly qualified, registered and legal voters of said precinct Joliet 3 are required to be on the ballot.

5. Your objector states that filing made contrary to such requirements must be voided, being in violation of the statutes in such cases made and provided.

6. Your objector states that the signatures on page 1 on Lines one through ten and page 2 lines one through four of the Petition of GEORGENE JABACK are not registered voters of Precinct Joliet 3.

7. Your objector states that the addresses on page 1 on Lines one through ten and page 2 lines one through four of the Petition of GEORGENE JABACK are located in Precinct Joliet 2 and not Precinct 3.

8. Your objector states that the signatures on page 1 on Lines one through ten and page 2 lines one through four of the Petition of GEORGENE JABACK are legally defective and deficient for the reasons that the signors do not live in Precinct Joliet 3 as stated in EXHIBIT A attached hereto and made a part hereof.

9. Your objector states that the signatures on page 1 on Lines one through ten and page 2 lines one through four of the Petition of GEORGENE JABACK are invalid and GEORGENE JABACK has failed to file the mandatory minimum seven signatures to be placed on the ballot.

WHEREFORE, your Objector prays that the nomination petition be declared by this Honorable Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois and that the name of GEORGENE JABACK be stricken and that this Honorable Electoral Board enter its decision declaring that the name of GEORGENE JABACK as a

candidate for election as a Precinct Committeeperson for Precinct Joliet 3 be not printed on the official Democratic ballot for the General Primary Election to be held on June 28, 2022.

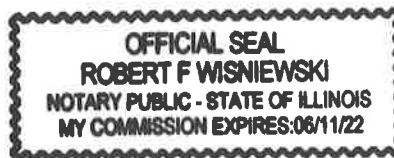
