VERIFIED OBJECTOR'S PETITION

Petitioner-Objector, Fred Gibson ("Objector") pursuant to 10 ILCS 5/10-8 respectfully moves this Board to nullify the candidacy of Nicholas Kaminski ("The Candidate" or "Mr. Kaminski" as appropriate) and in support thereof states as follows:

- 1. The Objector resides at 1023 Cassie Dr, Joliet, II, in the Troy Township Precinct 9, Will County, Illinois and is duly qualified, legal and registered to vote at his address.
- 2. The Objector's interest in filing this Petition is that of a voter desirous that the laws governing the filing of nomination papers for the Office of Democratic Precinct Committeeperson, Troy Township, Precinct 9, Will County Illinois are properly complied with, and that only qualified candidates appear on the ballot for said Office.

- 3. On March 10, 2022, Mr. Kaminski filed nominating papers with the Will County Clerk in order to appear on the ballot for the regularly scheduled Primary Election to be held on June 28, 2022.
 - 4. A review of these nomination papers reveals fatal flaws outlined in detail below:
 - a. Mr. Kaminski's's petition signature pages are NOT numbered consecutively as required by statute (10 ILCS 5/10-4) as well as the guideline document available to candidates by the Will County Clerk and the Illinois State Board of Elections. The first signature page is not numbered at all and should thus be deemed null and void. The second signature page is numbered incorrectly as page 1 so it too should be deemed null and void. (EXHIBITS 1 AND 2)
 - b. The one page that has a number on it, while it has failed to be numbered consecutively as required in the statute, contains just seven signatures. Of those seven signatures, two signatures do not match what is contained in the County Clerk's voter data base. The page incorrectly numbered as (1) on line 4 contains a signature that is not that of Harold Pitsenberger Jr and should be disallowed. Also on this same page, line 5 contains a signature that is not that of Colleen Allton It does not match the County Clerk's data base voter file and should be disallowed.
 - 5. Signature requirements for candidates for Precinct Committee Person are 7.
 - 6. Candidate Kaminski appears to have submitted a total of 5 valid signatures falling short, even if the misnumbered page is considered, of the 7 required in the nominating petition process.

WHEREFORE, the Objector requests a hearing based on the facts set forth herein, and a ruling that the name Nicholas Kaminski shall not appear and not be printed on the ballot for election to the Office of Democratic Precinct Committee Person, Troy Township, Precinct 9, Will County, Illinois, to be voted for at the Primary Election to be held June 28, 2022.
