OBJECTORS' PETITION

Now come Michael Lewandowski (hereinafter referred to as the "Objector"), and state as follows:

- 1. Michael Lewandowski resides at 17503 W. 143rd St., Lockport, Illinois 60441, in Precinct 5 of Lockport Township, County of Will, State of Illinois; that he is duly qualified, registered and a legal voter at such address; that his interest in filing the following objection is that of a citizen desirous of seeing to it that the laws governing the filing of nomination papers for a Candidate for Nomination and Election to the Office of Republican Precinct Committeeman, Precinct 5 of the Township of Lockport, County of Will, State of Illinois, are properly complied with and that only qualified candidates have their names appear upon the ballot as candidates for said office.
- 2. Your Objector makes the following objections to the nomination papers of Grant Spooner ("the Nomination Papers") as a candidate for the Office of Republican Precinct Committeeman, Precinct 5 of the Township of Lockport, County of Will, State of Illinois, and

files the same herewith, and states that the said Nomination Papers are insufficient in law and in fact for the following reasons:

3. Your Objector states that the Candidate has signed a petition a candidate of the Democrat Party in the current election cycle, stating that he is a member of the Democrat Party for purposes of placing that Democrat candidate on the General Primary Election ballot. Under the petition signature, the Candidate has stated his a "member[] of and affiliated with the Democratic Party and [a] qualified primary elector of the Democratic Party" "in the County of Will" and has, therefore, disqualified himself to be a candidate for elective office in the same election cycle as a member of the Republican Party. A person may only be a member of one political party during an election cycle. 10 ILCS 5/7-10 clearly states as follows:

A "qualified primary elector" of a party may not sign petitions for or be a candidate in the primary of more than one party.

10 ILCS 5/7-10. Grant Spooner's petition for candidacy for Lockport Township Precinct 5 committeeman in the Republican Party must be invalidated based on his affirmation that he is a member of and affiliated with the Democrat Party as well as a qualified primary voter thereof based on his signature to the candidate petition for a member of the Democrat Party (Exhibit A) in the same election cycle in which he seeks office as a Republican candidate. *Patton v. Illinois State Board of Elections*, 2018 (App 1st) 180425-U, appeal denied No. 123337 (March 13, 2018).

4. Further, your Objector states that the Candidate has circulated petitions for office for a member of the Democrat Party in the current election cycle, indicating that he is a member of the Democrat Party for purposes of the circulating those petition pages. A person may only be a member of one political party during an election cycle. 10 ILCS 5/7-10 clearly provides that a qualified primary elector of a political party may not sign a petition for or be a

candidate in the primary of more than one political party. Grant Spooner's petition for candidacy for Lockport Township Precinct 5 Committeeman of the Republican Party must be invalidated based on his apparent affirmation that he is a member of the Democrat Party based on the candidate petition pages he circulated for a member of the Democrat Party (Exhibit B) in the same election cycle he seeks office as a Republican candidate. *Patton v. Illinois State Board of Elections*, 2018 (App 1st) 180425-U, appeal denied No. 123337 (March 13, 2018).

In addition, nominating petitions circulated by a person who holds himself out to be a member of one political party, but who in the same election cycle seeks office as a member of another political party and swears he is a member of that political party must be disqualified as the circulator has misrepresented his political party affiliation to registered voters. 10 ILCS 5/7-10.

WHEREFORE, your Objector prays that the purported Nomination Papers of Grant Spooner as a candidate for the Office of Lockport Township Precinct 5 Republican Committeeman, Township of Lockport, County of Will, State of Illinois, be declared by this Honorable Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois; that the Candidate's name be stricken; and that this Honorable Electoral Board enter its decision declaring that the name of Grant Spooner as a candidate for the Office of Lockport Township Precinct 5 Republican Committeeman of Lockport Township, County of Will, State of Illinois, BE NOT PRINTED on the OFFICIAL BALLOT of the Republican Party at the General Primary Election to be held on June 28, 2022.
