

4. Your objector states that in Precinct Joliet 14 the signatures of not less than 7 duly qualified, registered and legal voters of said precinct Joliet 14 are required to be on the ballot.

5. Your objector states that filing made contrary to such requirements must be voided, being in violation of the statutes in such cases made and provided.

6. Your objector states that the signatures on page 1 on Lines one of the Petition of GLORIA LEDESMA is not a registered voter of Precinct Joliet 14 and it appears to be written by the person who signed line 2 and not signed in their own proper person.

7. Your objector states that it appears that the signatures on lines 3, 4, 5, 6 contain the names of persons who did not sign the said nomination petition in their own proper persons and that the signatures are not genuine as set forth in EXHIBIT A attached hereto and made a part hereof.

8. Your objector states that the signatures on page 1 on lines 8, 9, 10 contain the names of persons who did not sign the said nomination petition in their own proper persons and that the signatures are not genuine as set forth in EXHIBIT A attached hereto and made a part hereof.

9. Your objector states that the signature on Page 1 on line 10 is not a registered voter of Precinct Joliet 14.

10. Your objector states that the signatures on page 2 on Lines 2, 3, 4 of the Petition of GLORIA LEDESMA are duplicated on page 1 lines 8, 9, 10 contain the names of persons who did not sign the said nomination petition in their own proper persons and that the signatures are not genuine as set forth in EXHIBIT A attached hereto and made a part hereof and are invalid.

11. Your objector states that the signature on Page 2 on line 4 is not a registered voter of Precinct Joliet 14.

12. Your objector states that the signatures on page 1 on Lines 1, 3, 4, 5, 6, 8, 9, 10 and page 2 lines 2, 3, 4 of the Petition of GLORIA LEDESMA are invalid and GLORIA LEDESMA has failed to file the mandatory minimum seven signatures of registered voters to be placed on the ballot.

13. That GLORIA LEDESMA has acted and taken steps to establish a pattern of fraud and false swearing with an utter and contemptuous disregard for the mandatory provisions of the election code that undermine the integrity of the election process


WHEREFORE, your Objector prays that the nomination petition be declared by this Honorable Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois and that the name of GLORIA LEDESMA be stricken and that this Honorable Electoral Board enter its decision declaring that the name of GLORIA LEDESMA as a candidate for election as a Precinct Committeeperson for Precinct Joliet 14 be not printed on the official Democratic ballot for the General Primary Election to be held on June 28, 2022.

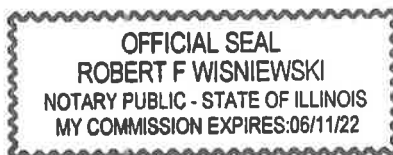
