VERIFIED OBJECTOR'S PETITION

NOW COMES, GARLAND MAYS hereinafter referred to as the "Objector," by and through his attorney, ROBERT F. WISNIEWSKI, and makes the following objections to the Precinct Committeeperson Petition of FELIX ORTIZ as a candidate for election as a Democratic Precinct Committeeperson from Joliet 6 and states as follows:

1. That the Objector GARLAND MAYS resides at 1317 Fairview Avenue, Joliet, Illinois which is in Joliet Township Precinct 6 in Will County, Illinois.
2. The Objector is a registered legal voter at such address.
3. That the Objector's interest in filing the following objections is that of a citizen desirous of seeing to it that the laws governing the filing of nomination papers for election to the office of Democratic Committeeperson for Joliet Township Precinct 6, Joliet, Will County,

4. Your objector states that in precinct Joliet 6 the signatures of not less than 7 duly qualified, registered and legal voters of said precinct Joliet 6 are required.

5. Your objector states that filing made contrary to such requirements must be voided, being in violation of the statutes in such cases made and provided.


6. Your objector states that the signature on Line one of the Petition of Felix Ortiz is not a registered voter of Precinct Joliet 6 and the address 424 Meeker Avenue, Joliet, Illinois is in Precinct Joliet 14 and not in Precinct Joliet 6.

7. Your objector states that the individual who signed Line five is not a registered voter of Precinct Joliet 6.

8. Your objector states that the signatures on Line one and five are legally defective and deficient for the reasons stated in EXHIBIT A attached hereto and made a part hereof.

9. Your objector states that the signatures on Lines one and five are invalid and Felix Ortiz has failed to file the mandatory minimum seven signatures to be placed on the ballot.

WHEREFORE, your Objector prays that the nomination petition be declared by this Honorable Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois and that the name of FELIX ORTIZ be stricken and that this Honorable Electoral Board enter its decision declaring that the name of FELIX ORTIZ as a candidate for election as a Precinct Committeeperson for Precinct Joliet 6 be not printed on the official ballot for the General Primary Election to be held on June 28, 2022.

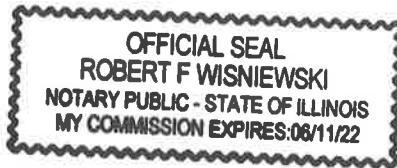
