DECISION AND ORDER

The Will County Officers Electoral Board, Chairperson Nancy Schultz Voots, County Clerk of Will County, Illinois through her designee Chief Deputy Clerk Judith L. Wiedmeyer, Mike Kelley, Sheriff of Will County, Illinois and James W. Glasgow, State's Attorney of Will County, Illinois through his designee, Assistant State's Attorney Mary Tatroe, reconvened on December 15, 2015 at 1:00 p.m. Objector Derrick E. Barry was present with his attorney Gary Mueller. The Candidate Barbara Guerrero was present in person. The Board adopted hearing rules unanimously on December 10, 2015 which governed the hearing. The matter was called for hearing in open session.

THE OBJECTION

The Board finds that the Objection alleges: (a) all but thirteen (13) sheets of the Nomination Papers and Petition include a reference, in the Block Heading, that the Position sought by the Candidate is for "Circuit Clerk, Term 4 District 2". As the position is for a Countywide position there should be no reference to district 2; (b) the Nomination Papers and Petitions contain the names of persons as circulators that lacks the party affiliation of the circulator; (c) the Nomination Papers and Petitions contain names of persons who signed nomination petitions for another candidate seeking nomination by the same political party for the same position; (d) The Nomination Papers contain sheets circulated by individuals whose sheets

demonstrate a pattern of fraud and disregard of the Election Code to such a degree that said Nomination Papers and Petition are invalid, and should be invalidated in order to protect the integrity of the electoral process; and (e) that the Nomination Papers contain less than the required 666 valid signatures to be placed on the ballot for the office of Nominee of the Democratic Party to the Office of Will County Circuit Clerk.

The hearing on the objection proceeded by way of an examination of applicable voter records in order to determine the validity of objected to signatures. The Objector offered no further evidence. The Candidate offered no evidence outside of the submitted petition.

Arguments were heard by the parties.

APPLICABLE STATUTORY PROVISIONS

10 ILCS 5/7-10 (c) requires the petition for countywide office in a county other than Cook County to be signed by at least the number of signatures equal to 0.5% of the qualified electors of his or her party who cast votes at the las preceding general election in the district in which the candidate is running for election. The term qualified elector is synonymous with registered voter.

FINDINGS

The Board finds that pursuant to the requirements of state statute, certified mail notices were sent by the Chairman of the Board to each of the Board members, the Candidate and the Objector within the time and in the manner required by statute giving notice of the time and place of the convening of the Board for hearing upon the objection. Additionally, within the time required by law, notice of the call was placed for service with the Will County Sheriff for service upon each of the members of the Board, the Objector and the Candidate giving notice of the time and place of the convening of the Board for hearing upon the objection. The documents evidencing compliance with the notice requirements of the statute were filed with the Board. The Board hereby finds that it has been legally constituted according to the laws of the State of Illinois in that the office sought was for Circuit Clerk and therefore Pamela J. McGuire the

current Circuit Clerk recused herself. The Treasurer Steve Weber was unable to serve in her stead and the Board was completed by Sheriff Mike Kelley. The Board has complied with the requirements of the Open Meetings Act and has jurisdiction over the Parties and the subject matter.

The Board further finds as follows:

The number of valid Democratic Party voter's signatures to place a candidate on the ballot for Will County countywide office is 666 signatures. The Nominating Papers of candidate Barbara Guerrero as delivered to the office of the County Clerk contained 911 signatures in support of that candidacy.

The objection to the Nomination Papers and Petition that all but thirteen (13) sheets of the Nomination Papers and Petition include a reference, in the Block Heading, that the Position sought by the Candidate is for "Circuit Clerk, Term 4 District 2" is fatally defective is overruled. The position sought of Circuit Clerk is a countywide position with a four year term and the erroneous "District 2" language would not confuse a voter signing the petition.

The objection that the Nomination Papers and Petitions contain the names of persons as circulators that lacks the party affiliation of the circulator is overruled. Substantial compliance with the election code is acceptable when the invalidating charge concerns a technical violation. *Madden v Schmann*, 105 Ill.App.3d 900,435 N.E.2d 173, 61 Ill.Dec. 684 (1st 1982)

The Objection that the Nomination Papers and Petitions contain names of persons who signed nomination petitions for another candidate seeking nomination by the same political party for the same position is overruled. An e-mail provided to the Will County Clerk from legal counsel for the State Board of Elections supports this finding.

The objection that the Nomination Papers contain sheets circulated by individuals whose sheets demonstrate a pattern of fraud and disregard of the Election Code to such a degree that said Nomination Papers and Petition are invalid, and should be invalidated in order to protect the integrity of the electoral process is overruled. The Board finds no evidence to support this objection.

The Board sustains 278 objections to signatures filed with the petition. The Board overrules 234 objections to signatures filed with the petition. The Board incorporates into this

Decision and Order the attached tally sheet of the specific findings as to each specific objection. Accordingly the Board finds 633 valid signatures to support the petition which is less than the 666 valid signatures required to cause the name of the candidate to be placed on the ballot.

ORDER

The Electoral Board orders the Will County Clerk to reject the nomination papers of Barbara Guerrero and to not print Barbara Guerrero's name upon the March 15, 2016 ballot. The Parties are informed that if they feel aggrieved by the decision of the Board they may seek judicial review of this decision by filing within 5 days of this decision a petition with the Clerk of the Circuit Court along with a proof of service to all Parties.
